What is 8minute solar energy on eland?

Will 8minutenergy repurchase eland?

California-based 8minutenergy will stay on to bring Eland through its final stages of development and has the right to repurchase a portion of the project upon its completion. The deal underlines the growing partnership between Capital Dynamics, a Switzerland-based asset manager, and 8minute, the California-based solar developer.

How much does eland solar cost?

Eland will be the third such hybrid project in its portfolio. The solar power-purchase agreement with LADWP undercuts previous records, coming in at less than \$20 per megawatt-hour. Combined with storage, the price is likely to be sub-\$40 per megawatt-hour, below other deals of its kind.

What is 8minute Solar Energy?

8minute Solar Energy (8minute) is a privately-held developer of solar PV and storage projects in the United Stateswith over 15 GW of projects under development. Founded a decade ago by President and CEO Dr. Tom Buttgenbach,8minute has more than 2 GW of solar power plants now in operation.

Eland will be one of the largest hybrid solar-and-storage facilities in the U.S.,adding to Capital Dynamics' fast-growing roster. CapDyn owns a number of the largest U.S. solar projects, with a growing interest in storage.

How many solar projects does 8minute have?

Since its founding in 2009,8minute has successfully put 2 GW of solar projects in operation and currently has over 18 GWof solar and 24 GWh of energy storage projects under development.


