

Could Mexico attract US\$17 billion of direct investment?

Mexico could attract US\$17 billion of direct investmentunder the highest accumulated renewable scenario. The impacts of greater renewable energy penetrations vary geographically and depend on the assumptions made when defining the new installed generation capacity for each scenario.

How much money did Pemex invest in a new refinery?

U.S. natural gas exports to Mexico via pipeline have increased more than 400% since 2011. In 2022, Pemex purchased ownership in the Deer Park refinery in Houston for \$596 million. In addition, a new refinery called Olmeca Dos Bocas, which will come online in 2023, was constructed at an estimated cost of \$12 billion.

Did Pemex make a profit in 2022?

Pemex (Mexico's state-owned oil company) reported a profit of 23 billion pesos (\$1.2 billion)in 2022 aided by higher oil prices.1 This is the first time the company posted a profit in a decade on an annual basis. Pemex used a \$2 billion bond to refinance some of its nearly \$105 billion debt in the third quarter 2022.2
