

Will Albania become a member of the European Union?

Albania is on the current agenda for future enlargement of the European Union (EU). It applied for EU membership on 28 April 2009, and has since June 2014 been an official candidate for accession. The Council of the European Union decided in March 2020 to open accession negotiations with Albania.

Will Albania join the European Union on Tuesday in Luxembourg?

Albania will open its first chapter of accession talks with the European Union on Tuesday in Luxembourg, as it aims to make headway in its decade-long bid to join the 27-country bloc. Tuesday's accession conference will be the second held between the EU and Albania since it became a candidate country in 2014.

When did the European Council open accession negotiations with Albania?

In March 2020 the members of the European Council endorsed the General Affairs Council's decision to open accession negotiations with Albania and in July 2020 the draft negotiating framework were presented to the Member States. In July 2022, the Intergovernmental Conference on accession negotiations was held with Albania.

How did Erasmus+ work in Albania?

11,500+ participants took part in exchanges between the EU and Albania in the areas of education, training, youth, and sport under ERASMUS+ (2014-2020). The EU has provided close to EUR33 million in support to civil society (2014-2023). The EU is supporting the establishment of the new College of Europe campus in Tirana.

How does the EU help Albania?

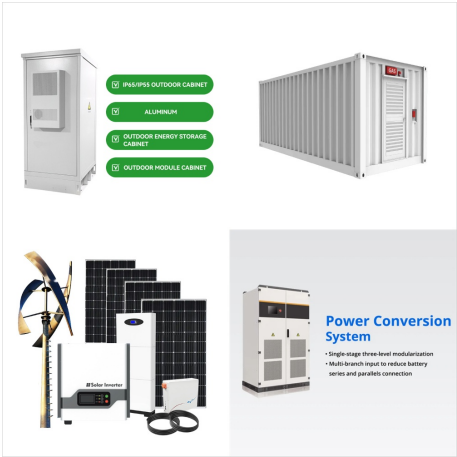

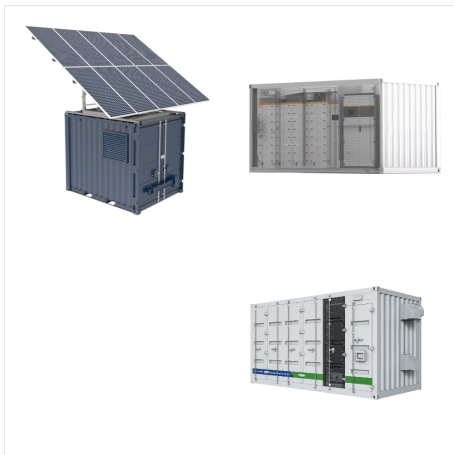
