

Allegheny Power System, Inc. is an electricity provider, serving a 29,100-square-mile area in the United Statescentered over the border shared by Pennsylvania and West Virginia and including parts of Maryland, Ohio, and Virginia.

Where is Allegheny Energy located?

Allegheny Energy was an electric utility headquartered in Greensburg, Pennsylvania. It owned and operated electric generation facilities and delivered electric services to customers in Pennsylvania, West Virginia, Maryland, and Virginia. Allegheny Energy was incorporated in Maryland in 1925 as West Penn Electric Company.

Who is Allegheny Energy Supply?

1999: Allegheny Energy Supply, LLC is formed. Allegheny Energy, Inc. controls both regulated and unregulated generation facilities and owns 8,593 megawatts of power. It provides electricity to markets in several mid-Atlantic states, primarily Pennsylvania and West Virginia, as well as parts of Maryland, Ohio, and Virginia.

Who owns Allegheny Energy?

In 2011 Allegheny Energy was acquired by FirstEnergy. Allegheny Energy is an investor-owned electricity utility which, through its subsidiaries Allegheny Energy Supply Company and Allegheny Power, operates power stations and delivers electricity to customers in Pennsylvania, West Virginia, Maryland, and Virginia.

How much power does Allegheny Energy produce?

Power portfolio Out of its total 9,290 MWof electric generating capacity in 2005 (0.87% of the U.S. total), Allegheny Energy produces 82.2% from coal, 16.4% from natural gas, 0.8% from oil, and 0.6% from hydroelectricity. Allegheny owns power plants in Pennsylvania, Virginia, West Virginia, and Tennessee.

When did FirstEnergy merge with Allegheny Energy?

In 2011,FirstEnergy expanded its customer base and service territory by completing a merger with Allegheny Energy,a Greensburg,Pennsylvania-based company that served 1.6 million customers in Pennsylvania,West Virginia,Maryland and Virginia.





Allegheny Power System, Inc. filed as a Foreign Business Corporation in the State of New York and is no longer active. This corporate entity was filed approximately eighty-two years ago on Wednesday, September 30, 1942, according to public records filed with New York Department of State. It is important to note that this is a foreign filing.





Under the terms of the agreement, Allegheny shareholders would receive 0.667 shares of FirstEnergy common stock in exchange for each share of Allegheny they own. Based on the closing stock prices for both companies on February 10, 2010, Allegheny shareholders would receive a value of \$27.65 per share, or \$4.7 billion in the aggregate.

On May 14, 2010, Allegheny Power, TrAILCo and FirstEnergy filed a joint application to obtain approval for a change of control of Allegheny and TrAILCo. Allegheny and TrAILCo will merge with a wholly-owned subsidiary of FirstEnergy. On Aug. 3, 2010, a public input hearing to receive comments on the application was held in Greensburg.



Through this merger, FirstEnergy became the holding company for Ohio Edison and its Pennsylvania Power Company subsidiary, as well as The Cleveland Electric Illuminating Company and The Toledo Edison Company.
