How much money did BAPCO energies raise in sukuk?

Bapco Energies raised another US\$1 billionin sukuk in October 2018. In November 2020, Bahrain adopted a strategy for supplying homes, industry, and government buildings with natural gas.

What is BAPCO gas?

Bapco Gas promotes oil production from the Bahrain Field,treats process-associated gas and the extraction of marketing products,and supplying local industries with surplus gas. Bapco Tazweed manages the national infrastructure of service stations,and is the destination of choice for fueling and convenience.

Who is BAPCO refining?

Bapco Refining offers one of the highest-quality refining capabilities in the Middle East, and manages the largest energy investment in the Kingdom of Bahrain- Bapco Modernization Program (BMP).

How much money did BAPCO energies raise in 2021?

Bapco Energies raised US\$600 millionin sukuk in April 2021, and another US\$2.2 billion in murabaha (a sharia-compliant bond similar to a cost-plus pricing agreement) in May 2022. About US\$1.6 billion was used to refinance older debt. This was the first time Bapco Energies had issued sustainability-linked financing instruments.


