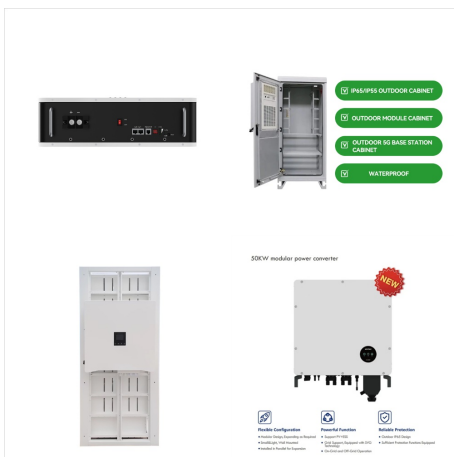
What does Hyperion's PERC supply contract mean for US customers?
