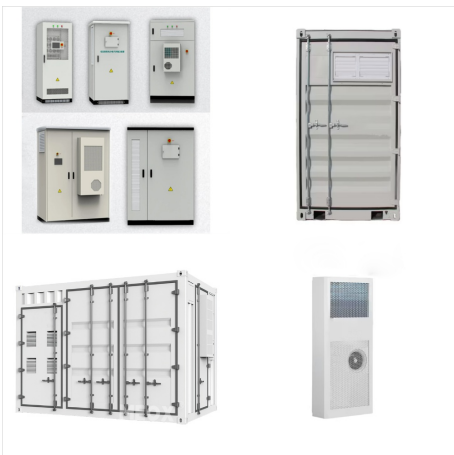

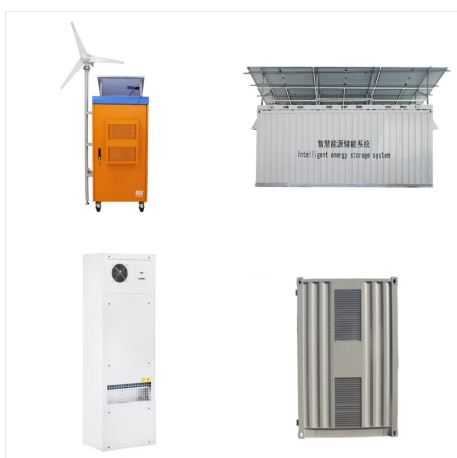

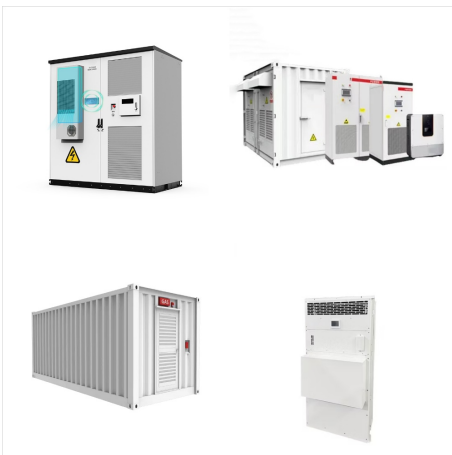

According to the agreement, Avangrid Renewables will own the lease area OCS-A 534, which includes the 804MW Park City Wind project and the prospective 1,200MW Commonwealth Wind project. CIP will also receive a net payment of \$167.5m from Avangrid Renewables when the deal closes, which is expected to happen in the next six months.

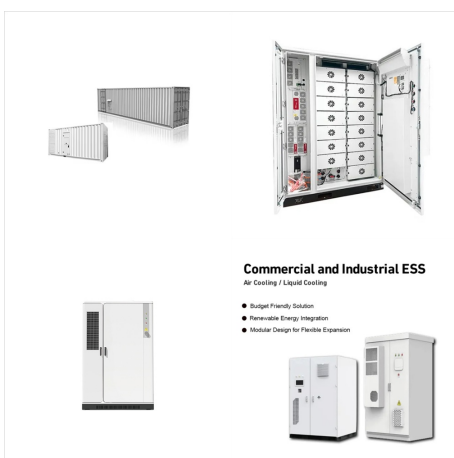
