The Fowler Ridge Wind Farm is a wind farm in Benton County, Indiana, near the city of Fowler, IN about 30 miles (48 km) northwest of Lafayette and 90 miles (140 km) northwest of Indianapolis. [1] Fowler Ridge was originally developed in 2005 and 2006 by Orion Energy, LLC (Oakland, CA) and Vision Energy, LLC (Cincinnati, OH) and later sold in 2007 to BP and Dominion Resources.

Last week, AES Indiana, a subsidiary of The AES Corporation (NYSE: AES), closed on the acquisition of the 106 MW Hoosier Wind project, located in Benton County. The Indiana Utility Regulatory Commission (IURC) approved the acquisition from EDF Renewables North America, giving AES Indiana ownership of the asset.

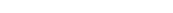




