



What does Bess stand for?

The contracts were for the 20-MW Brindisi battery energy storage system(BESS) in southern Italy and the 6-MW Sassari unit in Sardinia, which will provide fast reserve grid services for Italian transmission system operator Terna SpA (BIT:TRN).

How is Bess used in Italy?

How BESS are used Currently, the main possible sources of revenues for BESS in Italy are the following: specific auctions and the capacity market(BESS facilities participated in the 2022, 2023 and 2024 capacity market auctions).

How does Terna remuneration work?

Terna will launch and manage specific auctions for the realisation of this BESS capacity. The remuneration system for the players that have built the BESS consists of a fee paid by a third party handling the participation of the plants in the energy market and related services.

How much does Terna's fast reserve service cost?

Transmission system operator Terna held its Fast Reserve Service pilot tender in 2020, awarding 250MW of five-year contracts, after receiving 1,327MW of bids. Contracts were awarded at a weighted average price of EUR29,500 /MW /year(US\$33,500), well under expected price benchmarking of between about EUR78,000 and EUR108,000 per MW.

How many GW will Terna spa deliver in 2024?

Italian grid operator Terna SpA (BIT:TRN) on Tuesday assigned contracts for 41.5 GW in the capacity market auction for the 2024 delivery year, including 12.9 GW of awards to energy major Enel SpA (BIT:ENEL). This auction round is the third one, with auctions already held for the delivery years 2022 and 2023.

What is a Bess remuneration system?

The remuneration system for the players that have built the BESS consists of a fee paid by a third party handling the participation of the plants in the energy market and related services. The "Gestore dei Mercati Energetici" (GME) will set up a specific platform for the selection of third parties.
