BP announced today that it has entered into an agreement to sell its interests in Pan American Energy (PAE) to Bridas Corporation. PAE is an Argentina-based oil and gas company owned by BP (60 per cent) and Bridas Corporation (40 per cent).. Bridas Corporation will pay BP a total of \$7.06 billion in cash for BP's 60 per cent interest in PAE.





PAEG will be owned equally by BP and Bridas, which itself is a 50-50 joint venture of Bridas Energy Holdings of Argentina and CNOOC Ltd. of China. PAE is currently owned 60% by BP and 40% by

The new company, Pan American Energy Group (PAEG), will be the largest privately-owned integrated energy company operating in Argentina. PAEG will be owned equally by BP and Bridas Corporation, itself a 50:50 joint venture of Bridas Energy Holdings of Argentina and CNOOC Limited of China.



The field is owned by Repsol, Yacimientos Petroliferos Fiscales Bolivianos, China National Offshore Oil, Bridas Energy Holdings, BP and Shell. Production from Iniguazu Production from the Iniguazu conventional gas development project is expected to begin in 2022 and is forecast to peak in 2028, to approximately 354 Mmcfd of natural gas.





Margarita-Huacaya Complex is located in Santa Cruz, Bolivia. This natural gas field is owned by BP (12.50%), Bridas Energy Holdings (6.25%), China National Offshore Oil (6.25%), Repsol (37.50%), Shell (37.50%) and operated by Repsol E& P Bolivia. The field produced 417.7mmcfd in 2023 and recovered 68.48% of its total recoverable natural gas

CHINA National Offshore Oil Corp, China's biggest offshore oil explorer, plans a joint venture with Argenina's Bridas Energy Holdings, paying \$3.1bn (?2.04bn) to take a 50 per cent stake in a



Bridas Corporation itself is a 50:50 joint venture of Bridas Energy Holdings of Argentina and Chinese state-owned CNOOC; the latter bought its stake in 2010 for \$3.1bn. PAE, which in 2015 had 983mn barrels of oil equivalent reserves in Argentina, issued a statement December 11 saying that it expected completion of the merger early 2018.



Under the terms of the deal, Bridas Energy Holdings and Cnooc will each contribute roughly \$2.5 billion toward the acquisition, while Bridas will take \$2.1 billion in bank loans to finance the rest. Bridas will pay BP a \$3.5 billion cash deposit by Dec. 28, with the balance due by the deal's close, expected next year.
