Energy Snapshot Bonaire This profile provides a snapshot of the energy landscape of Bonaire, a special municipality of the Kingdom of the Netherlands located off the coast of Venezuela. Bonaire's utility rates are approximately \$0.35 per kilowatt-hour (kWh), above the Caribbean regional average of \$0.33/kWh. Bonaire is a leader



Additionally, Bonaire, as part of the BES Islands (Dutch Caribbean Islands) with Sint Eustatius and Saba, is among the 30 selected Clean energy for EU islands aiming to achieve complete energy independence by 2030. Bonaire is committed to elevate the proportion of renewables in its energy portfolio, ensuring clean, reliable, and affordable

developing areas. Energy self-sufficiency has been defined as total primary energy production divided by total primary energy supply.
