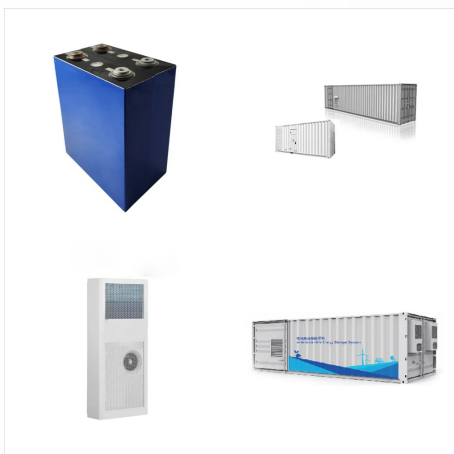

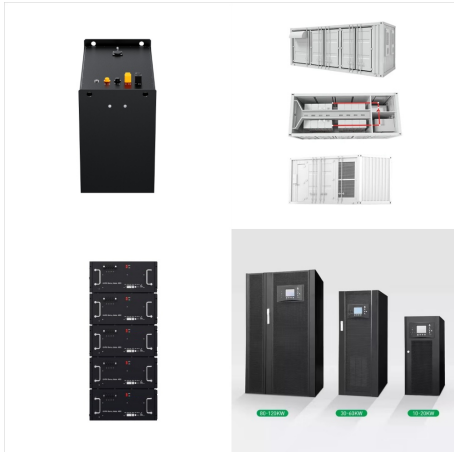
Bosnia And Herzegovina Renewable in % Electricity Production. Under its draft NECP (2023), Bosnia and Herzegovina aims to reach a share of 43.6% of renewables in final energy consumption by 2030 (up from 36.6% in 2021), including 70% for electricity, 61% for heating and cooling, and 8.4% for transport (46%, 53%, and 0.2%, respectively, in 2021).



A subsidiary of the state-owned power utility ERS, "Hidroelektrane na Trebišnjici" (HET), has generated 1,020 GWh of electricity so far this year, which is 7.5% more than the cumulative plan, exceeding the target by 70 GWh, according to Milan Mitrović, Executive Director for System Management at the company. Mitrović stated that HET is on track to meet ???



In the long run, the World Bank estimates that BiH's energy sector would require more than \$6 billion in investment for modernization, life extension, and new generation facilities for the power generation and coal mines sectors. BiH has significant renewable energy potential, particularly in hydropower and wind power capacity.
