

It is a protected nature reserve, and situated in the South Atlantic Ocean at the southern end of the Mid-Atlantic Ridge, it is the world's most remote island.



By its acquisition on 7 June 2010 of Areva T& Ds transmission business, Alstom completes a decisive stage in its development by forming a new sector, named Alstom Grid, to supplement the existing two sectors in power generation and rail transport, Power and Transport.



It is hoped that a hybrid interconnector will become an alternative grid solution for new offshore wind farms on the Norwegian shelf in 2025. The North Sea will generate 300GW of green electricity by 2050.




