There is no other way to legally obtain the tier 1 list. Pirate versions released on the internet may have been doctored. The list of tier 1 manufacturers is available to BNEF's subscribers quarterly. Note that a tier 1 listing is not a recommendation for the company or its products.

Who are bnef's 'major' or 'bankable' suppliers?

BNEF is frequently asked for a list of 'major' or 'bankable' suppliers for use in manufacturing forecasts, preliminary competitor analysis and other internal comparisons. In industry parlance, such firms are typically referred to as 'tier 1' players, but the term is seldom defined or described,

What is Brazil's largest battery storage project?

Further details about Brazil's largest battery storage project to date have been revealed including its integrators and equipment providers. The inauguration of the 30MW/60MWh system took place last year, on the networks of transmission system operator (TSO) ISO CTEEP, as reported by Energy-Storage.news in November.

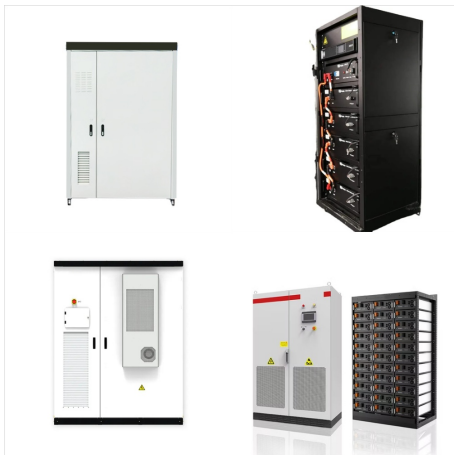

On 23 October 2024, Bloomberg New Energy
Finance (BNEF), a globally renowned research
institution for the new energy industry, released its
"Q4 2024 Global Tier 1 Energy Storage List".
PotisEdge has been named a "Tier 1" energy
storage supplier for the second consecutive quarter.



Brazil's regulatory framework does not prohibit energy storage solutions, but there are currently no specific regulations on storage. At the end of 2023, most BESS applications in Brazil were behind the meter. There is a proposed law on energy storage to encourage front-of-the-meter BESS, but Congress has not prioritized its approval.
