

What is the British Indian Ocean territory (BIOT)?

The British Indian Ocean Territory (BIOT) is administered from London. We work to support security and good governance, and preserve marine environment and historical heritage. The British Indian Ocean Territory has been under continuous British sovereignty since 1814.

How is the British Indian Ocean territory governed?

The constitutional arrangements for BIOT are set out in the British Indian Ocean Territory (Constitution) Order 2004 and related instruments. The Territory is administered from London, by a Commissioner appointed by The Queen, who is assisted by a Deputy Commissioner and Administrator.

What is the 'British Indian Ocean territory (Constitution) Order 2004'?

Today, the relevant Order in Council is the 'British Indian Ocean Territory (Constitution) Order 2004'. All Ordinances and Statutory Instruments for the BIOT are enacted by the BIOT Commissioner without recourse to higher authority, and free of any democratic scrutiny, including the UK Parliament.

What are the laws of the British Indian Ocean territory?

The laws of the BIOT derive their authority under the Royal Prerogative. Through the 'British Indian Ocean Territory Order 1965' (an Order in Council), the Queen vested duties and powers on the Commissioner to make 'laws for the peace, order and good government of the Territory'.

Is there a native population in the British Indian Ocean territory?

There is no native population on the islands. BIOT is constitutionally distinct and separate from the UK, with its own laws and Administration. The constitutional arrangements for BIOT are set out in the British Indian Ocean Territory (Constitution) Order 2004 and related instruments.

Does the British Indian Ocean territory have a 'secrecy'?

The infamous Ordinance to which Aust referred, banned all persons from the islands. However, the same 'secrecy' applies to all of the legislation of the British Indian Ocean Territory, both then and now. It is not widely publicised. A copy of each BIOT Gazette is required to be deposited in the British Library for public access.

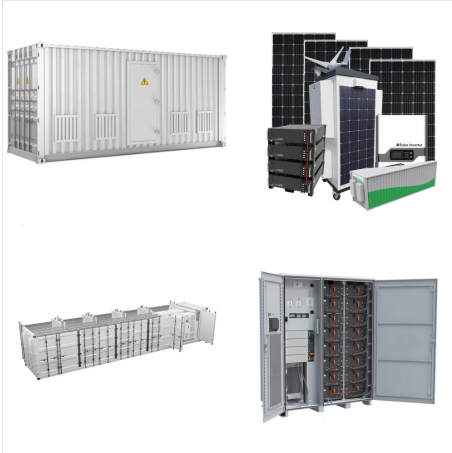

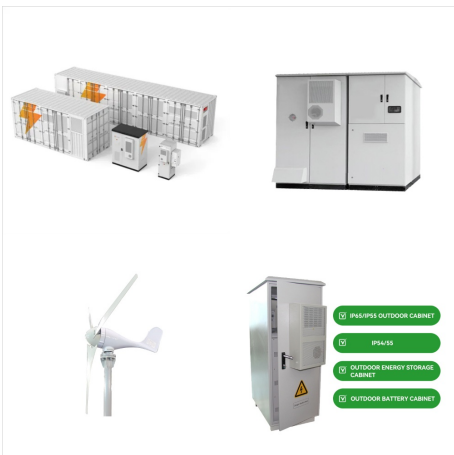
