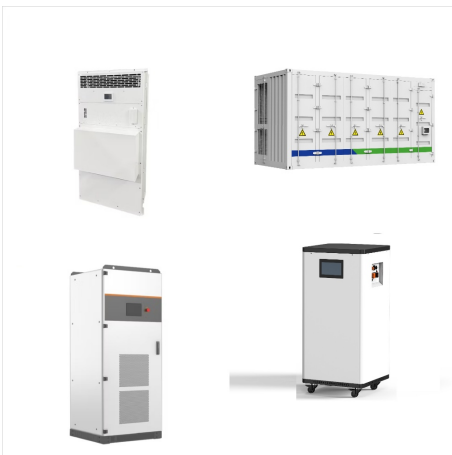

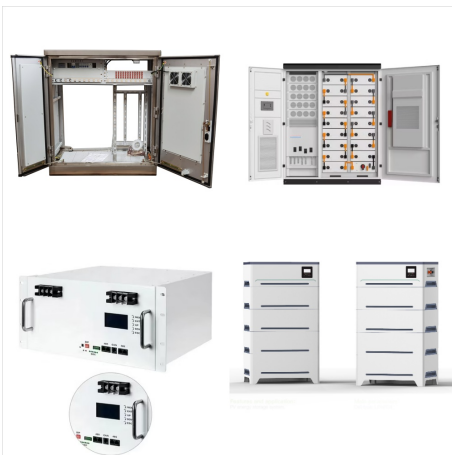

# CALIFORNIA RENEWABLE ENERGY SCAM



Senate Bill (SB) 100 established a landmark policy requiring renewable energy and zero-carbon resources supply 100 percent of electric retail sales by 2045. It requires the California Energy Commission, California Public Utilities Commission, and California Air Resources Board to submit a report to the Legislature every four years.



The spread of misinformation about solar and wind energy is leading some states and counties to restrict or even reject projects. Researchers say it's a threat to reducing greenhouse gas emissions.

# CALIFORNIA RENEWABLE ENERGY SCAM



The Clean Energy and Pollution Reduction Act (Senate Bill 350) established clean energy, clean air, and greenhouse gas (GHG) reduction goals, including reducing GHG to 40 percent below 1990 levels by 2030 and to 80 percent below 1990 levels by 2050. The California Energy Commission is working with other state agencies to implement the bill.
