

What is California's 2020 solar mandate?

California's 2020 Solar Mandate requires all newly built homes to install solar photovoltaic systems. These requirements are based on the floor area of the home and the climate zone. The solar panel systems must be sized to provide for the full annual energy usage of the home.

What are California's Solar mandates?

California has led the charge toward cleaner energy sources with efforts to make solar more widespread throughout the state. One part of this push is the California Solar Mandates.

Does California require solar for new homes?

The updated California solar mandates of 2020 required that all newly built residential homes meet Title 24 requirements. This update made California's code the first in the nation to require solar for newly built homes!

Do solar panels have to comply with California Electrical Code?

Individual components of solar PV systems must comply with the California Electrical Code. This requirement applies to several system components, including but not limited to the installation's panels, modules, wire, inverters, connectors and disconnects.

Will community solar be required in California?

The Public Utilities Commission declined to address community solar in last week's decision but is developing a new incentive program in a separate proceeding, as required by state law. Also worth noting: Under an existing regulation, all new homes built in California are required to come with solar. Last week's decision doesn't change that.

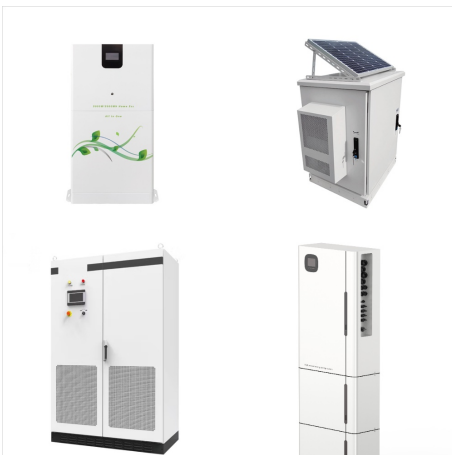

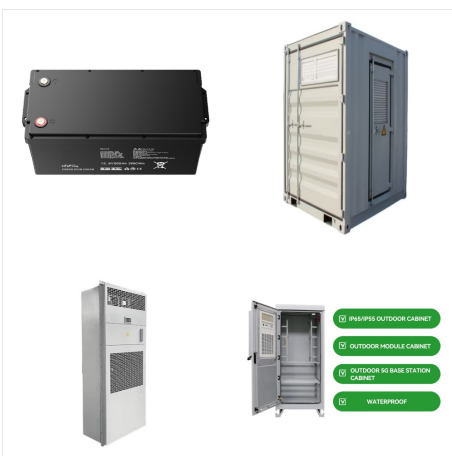

If your solar provider refuses to cancel the contract, report them to the Contractors State License Board (CSLB) at this link. **YOU HAVE THE RIGHT** to a Solar Disclosure Document from your solar provider. By law, a solar provider must provide a Solar Energy System Disclosure Document created by the CSLB and California Public Utilities Commission.

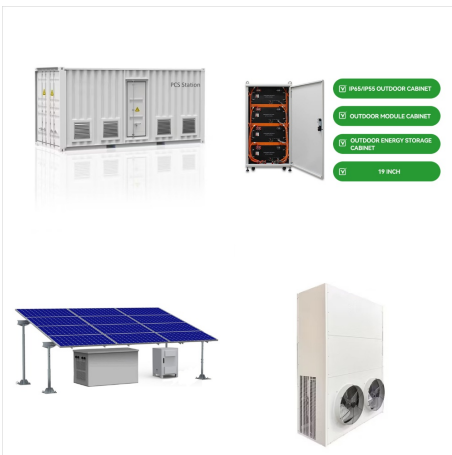

AB 1124 decreases the permit fees local building departments can charge for solar energy systems. It also changed the definition of "solar energy systems" in the law to include solar racking, solar carports, and other structural solar energy systems.
