

Do sole proprietors need a business name?

Sole proprietorships must register their business under the owner's legal name. Most sole proprietors, such as freelancers, do business under their legal names. The sole proprietor may not need a company name or extra branding. They are comfortable with using their personal name.

While there are some restrictions on sole proprietorship business name registrations, you can still find a name that aligns with marketing and branding efforts. Depending on your preferences, you may either use your name or a fictitious business name. Keep in mind several rules to stay on the legal side of things.

Can a sole proprietor have a business partner?

As a sole proprietor, there's no separation between your personal and business assets and expenses. You are personally responsible for all your business's debts and obligations. A sole proprietorship can only have one owner. If you take on a business partner, your unincorporated business will become a general partnership.

Can a sole proprietor use a trade name?

However, many sole proprietors use a trade name for marketing purposes or to keep their personal identities separate from their business. If you plan to use any name other than your personal name, you'll register a DBA name. For instance, Jane Smith doing business as "The Wedding Seamstress."

If you are the sole member of a domestic limited liability company (LLC) and elect to treat the LLC as a corporation, you are not a sole proprietor. 





When deciding upon a business name for your sole trader business, you have a great degree of flexibility. You can trade using your own name or come up with a branded name that fits your business. Companies House and the trade mark register are useful for checking any names you have in mind to avoid duplication.



Registering Your Sole Proprietorship. Unlike an LLC or a corporation, you generally don't have to file any special forms or pay any fees to start working as a sole proprietor. All you have to do is state that your business is a sole proprietorship when you complete the general registration requirements that apply to all new businesses.



Changing of Business Name. As a sole proprietor, he can conduct business under his own name or register another "doing business as a name with the state government. Suppose the new owner wishes to continue doing business under the same DBA. In that case, the sole proprietor must fill out a change of ownership form, if one is available.

A sole proprietorship can operate under the name of its owner or it can do business under a fictitious name. The fictitious name is simply a trade name; it does not create a legal entity separate from the sole proprietor owner. Only the proprietor has the authority to make decisions for the business.



Sole proprietors don't have to be registered with Business Registry unless they are using an assumed business name. If the name of the business doesn't include the full legal name of the business owner, the business name must be registered as an assumed business name with Business Registry. 





Request priority service (\$100 fee) if you need to have a name approved in 1 to 2 business days. Register a "doing business as" (DBA) name to operate an existing company under another name (e.g. a numbered company that does business under a DBA name). Any company or organization can use this option except sole proprietorships.
