

Can I ship a lithium battery cross-border?

There are regulations attached to the cross-border shipping of batteries to ensure they travel safely. These regulations vary depending on the type of batteries. Lithium batteries, for example, are classified as Dangerous Goods, so not all types of lithium batteries are accepted by DHL Express which you can check [here](#).

Can I ship a lithium ion battery?

Regulations differ depending upon what type of lithium battery you are shipping (lithium ion or lithium metal) and whether you are shipping batteries packed with equipment or batteries contained in equipment. Please see Figure 7 (page 8) and Figure 9 (page 10) for additional information.

Do I need a specific lithium battery Shipping Class?

FedEx Ground strongly recommends that anyone shipping lithium batteries take a specific lithium battery shipping class in order to better understand these complex regulations and meet DOT/ICAO/IATA/IMDG/USPS requirements.

Do I need a lithium battery approval before shipping?

UPS requires all lithium metal battery air shippers to be approved prior to shipping. Please review the requirements for lithium metal battery approval: Lithium ion (Li-ion) batteries are rechargeable. Lithium metal batteries are generally non-rechargeable.

What types of batteries should I pack and ship?

Can You ship a battery across a country?

Note. Effective July 1, 2015, all existing customers and new customers who wish to ship lithium metal batteries without equipment (UN3090) via UPS (R) Air services must obtain pre-approval from UPS Airlines. This requirement is to ensure that proper training has occurred and that all applicable safety regulations are properly followed for such shipments.

Lithium ion (rechargeable) - 20 watt-hour per cell or 100 watt-hour per battery

Different rules apply depending on whether you are shipping by ground or ???



If battery is not installed, must ship as "UN 3091, Lithium Metal Batteries Packed with Equipment" or "UN 3481, Lithium Ion Batteries Packed with Equipment", as applicable. There is no battery size designation (small, medium or fully regulated) for these entries.

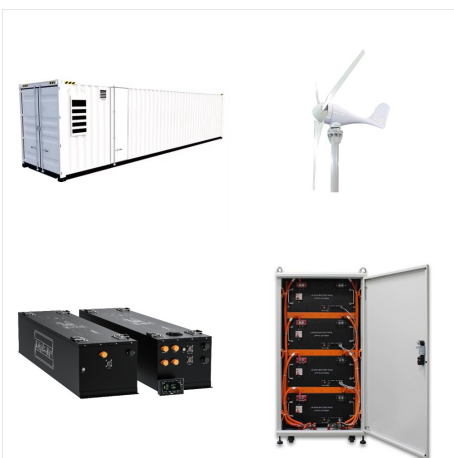
