A: Yes, you can consider suing your solar energy installer for the issues you've described. Given that the solar panels have been non-functional for over a year, with the company failing city inspections six times and not scheduling a correction for over three months, you may have grounds for legal action based on breach of contract, negligence, and possibly fraudulent ???

Can I sue a solar company that has breach contract, gone out of business and left me without Solar insurance? One year ago, we signed a contract with a Kuubix energy that just recently close shop. Since the panels stopped working shortly after starting, the company sent out a subcontractor in Florida to do the repairs.






Many companies include arbitration clauses in their contracts, meaning that you can't sue them in court, but have to go before a private arbitrator who will decide your lawsuit. But arbitration has complicated rules, and most consumers don't win unless they have an attorney.

A Settlement has been reached in a class action lawsuit against BP Solar and Home Depot involving solar panels manufactured between 1999 and 2007 with an S-type junction box ("Class Panels"). You may be entitled to benefits from a \$45.33 million common fund.



Whether (and when and where) you can sue this solar company depends what the contract you signed says. You'll need to review it yourself, or hire a lawyer for help. Not sure why you don't have hard copies of what you signed, but anyway, electronic signatures are good everywhere, so presumably you have a digital copy of what you agreed to.



To sue under a breach of warranty, many states require you to first notify the solar company, and to let them know about the problem soon after you learn about it yourself.
