

Can you carry a lithium ion battery on a plane?

Lithium-ion batteries, including those in laptops and power banks, are allowed but limited to 100 watt hours per battery, with the option to carry up to two larger 101-160-watt-hour batteries with airline approval. Lithium metal (non-rechargeable) batteries are permitted up to 2 grams of lithium per battery.

Can you bring a battery on a plane?

Requirements vary based on the type of device and size of battery. Spare (uninstalled) lithium metal batteries and lithium ion batteries, portable rechargers, electronic cigarettes and vaping devices are prohibited in checked baggage. They must be carried with the passenger in carry-on baggage.

Should you travel with lithium batteries?

Traveling with lithium batteries has become commonplace as they power everything from smartphones to laptops, cameras, and even medical devices. In May 2023, the Federal Aviation Administration (FAA) revealed that lithium-ion battery fires had jumped 42 percent in the last five years.

How do you use a lithium battery on a plane?

In-Flight Usage: Use devices powered by lithium batteries responsibly. Keep them in sleep mode or turned off when not in use. If you must use a device during the flight, keep it at a moderate temperature and avoid placing it under heavy items that could cause damage.

Can lithium batteries cause a fire on a plane?

Smoke and fire incidents involving lithium batteries can be mitigated by the cabin crew and passengers inside the aircraft cabin. If carry-on baggage is checked at the gate or planeside, spare lithium batteries, electronic cigarettes, and vaping devices must be removed from the baggage and kept with the passenger in the aircraft cabin.

Power packs or devices with internal batteries that have a capacity of greater than 300 watt hours are banned in both carry-on and checked luggage. And, of course, that applies to spare batteries over 300 wh as well. Note: To determine watt hours (Wh), multiply the volts (V) by the ampere hours (Ah).

For lithium metal batteries, the limit is 2 grams of lithium per battery, while for lithium-ion batteries, the limit is 100-watt hours per battery.




For a lithium metal battery, lithium content cannot be more than 2 grams per battery; For lithium-ion batteries, a maximum of 2, not exceeding 160 Wh each, are allowed in carry-on bag with airline approval; Traveling with lithium batteries Opens another site in a new window that may not meet accessibility guidelines



Well, you can actually bring two batteries on the plane with you that are larger than 100 watt-hours but smaller than 160 watt-hours. Flying with Lithium Batteries: What You Need to Know.



All other battery restrictions still apply e.g. no more than two spare lithium batteries exceeding 100Wh and up to 160Wh, are permitted and forms part of the total carried. A combination of batteries may be carried e.g. 10 x 98Wh lithium ion + 2 x 138Wh lithium ion + 2 x 12V and 98Wh non-spillable + 6 x alkaline.


Batteries containing more than 0.3 g of lithium or with a capacity of over 2.7 Watt-hours may not be checked in nor carried onboard. Removable lithium batteries: Capacity of the lithium battery must be lower than 160 Watt-hours: If the smart baggage is checked in, the battery must be removed and carried as carry-on baggage.



Whether you're flying anytime soon or otherwise, it's important to keep in mind the restrictions on traveling with lithium-ion batteries. 
The amount of lithium (or lithium equivalent) content in a battery or battery pack a?? this can be worked out as  $0.3 \times \text{amp hour capacity}$ . So a 2Ah battery has 0.6 grams of lithium ( $2 \times 0.3$ ) and a typical laptop battery pack with eight 2Ah cells has 4.8 grams (  $8 \text{ units} \times (0.3 \times 2\text{Ah})$  )

This covers typical dry cell batteries, lithium metal, and lithium ion batteries for consumer electronics (AA, AAA, C, D, button cell, camera batteries, laptop batteries, etc.) Spare (uninstalled) lithium metal and lithium ion batteries are always prohibited in checked baggage and must be placed in carry-on.

Small lithium battery-powered vehicles are not accepted in either checked baggage or carry-on baggage due to safety concerns associated to the lithium batteries that power them. Prohibited vehicles include: hoverboards, AirBoards, electric skateboards, airwheels, mini-Segways, balance wheels, battery-assisted bikes and electric scooters.



Tablets are known for having lithium batteries. Larger lithium batteries. If you want to bring larger lithium ion batteries you have to abide by special size requirements and also get permission from the airline. With airline approval, you can carry up to two spare larger lithium ion batteries (101a??160 Wh) or Lithium metal batteries (2-8 grams).
