#### Can a lithium battery be shipped?

Lithium batteries that power up scooters,hoover boards,electric skateboards,and e-bikes exceeding 100 Wh (Watt hours) cannot be shipped. Devices such as cellphones,watches,and vape with a single cell over 20Wh per cell cannot be mailed. Multiple cell batteries inside the housing or casing exceeding 100Wh for each battery are nonmailable.

Can I ship a battery via USPS?

Your batteries might be eligible for shipping via U.S. mail, but you need the right battery packaging to make those shipments compliant. You must follow USPS Packaging Instructions 9D strictly to prevent batteries from short-circuiting, overheating or catching fire.

How do I ship a lithium battery?

USPS has official instructions and guidelines for shipping batteries. ShipSaving helps you to highlight the following information: All packages containing lithium metal or lithium-ion batteries that can be mailed must be of sufficient size, sealed, and rigid. This ensures that the lithium battery mark can be affixed to the address without folding.

#### Can a battery be mailed?

Multiple cell batteries inside the housing or casing exceeding 100Wh for each battery are nonmailable. Damaged/recalled individual batteries are prohibited and need approval. Domestic shipping via air: Maximum 8 cells or 2 batteries with or installed in the new or Manufacturer Certified Refurbished (MCR) equipment in the same package.

Is lithium battery shipping dangerous?


While classified as a dangerous good, lithium battery shipping takes very specific requirements. that you can find inside the Dangerous Goods Regulations. However, if you only ship lithium batteries you can purchase the Lithium Batteries Shipping Regulations as a standalone manual.

Can I send items with lithium batteries?

Providing the postal authority has received approval from their Civil Aviation Authority, then you may be able



to send items which contain lithium batteries. Power banks, which contain lithium batteries and which are used to recharge or power other devices, are categorised as lithium batteries and are not permitted under this provision.



USPS Standards for Domestic Shipments Containing Lithium Batteries. Each cell cannot contain more than 1 gram of lithium; Each battery cannot contain more than 2 grams of lithium; All packages must contain a complete return address; For non-installed batteries, your package must have a DOT-approved lithium battery mark (UN3090)

No lithium battery markings permitted. Quantities must be within the limits of 622.5 and as outlined below. Lithium-ion batteries properly installed in the equipment they are intended to operate: Mailable internationally when permitted by country, including to and from APO, FPO, and DPO locations. No lithium battery markings permitted.

Yes, you can mail Lithium batteries. The best way to send lithium batteries is in a small box with lots of padding, so that they don"t get damaged during the shipping process. In order to send lithium-ion batteries through FedEx you will need to contact your local FedEx office and ask them if they can ship these batteries.

Lithium battery mark labels are not required for packages that contain no more than four cells or two batteries contained in devices. Section 2.4.1: The Universal Postal Union Convention forbids the carriage of Dangerous Goods in mail except as permitted in accordance with Section 2.4.2 of the IATA Regulations. Appropriate national

When using an air transportation service like Priority Mail, you''ll need the UN3481 Lithium Battery Handling Label. Sometimes, you may need to ship with a ground-based service, like when the lithium ion batteries are separate from the equipment they power. In this case, you''ll need to affix this UN3480 label.

Note. Effective 1 July 2015, all existing customers and new customers who wish to ship lithium metal batteries without equipment (UN3090) via UPS (R) Air services must obtain pre-approval from UPS Airlines. This requirement is to ensure that proper training has taken place and that all applicable safety regulations are properly followed for such shipments.



As a guide, a lithium battery in a mobile phone or laptop will not normally exceed 100Wh. Find out the approximate weights of the items to be posted. 2. Confirm carrier restrictions. Ask the carrier what their restrictions are for posting lithium batteries. Restrictions will probably include: A maximum number of lithium batteries per package.





The lithium batteries must be of a type that have successfully passed the UN38.3 tests and contain the necessary systems to prevent overcharge and over discharge between the batteries.
