The Solar Investment Tax Credit (ITC) is a federal tax credit that is a dollar for dollar reduction on income taxes. In 2022, the federal government increased the credit to 30% and extended it until 2032.. The state of Texas does not offer a statewide solar

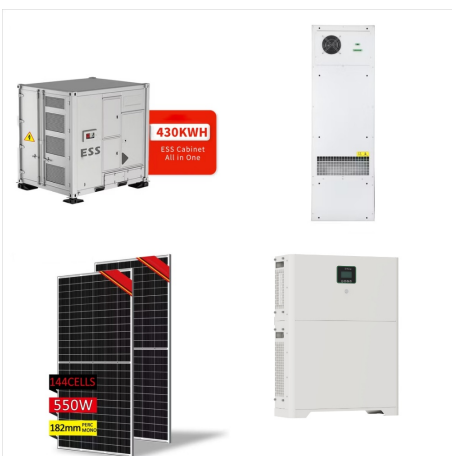

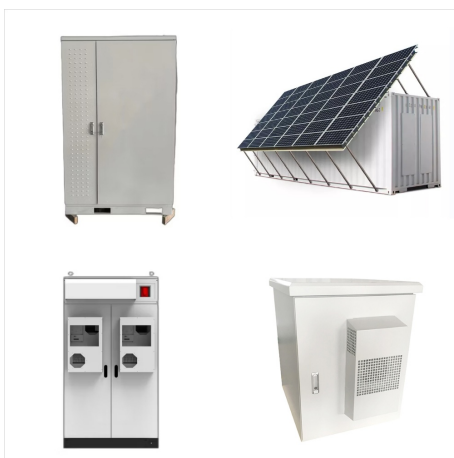

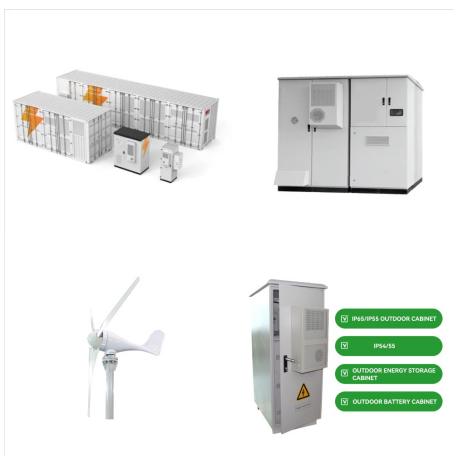

IRA Incentives Considered The renewable energy investment tax credit ("ITC"), as modified by the Inflation Reduction Act ("IRA"), contained in 26 U.S.C. ? 48, may provide an incentive for Hennepin County or its on-site solar production. CenterPoint Energy plans to purchase any grid electricity under an
