Rooftop solar panels are the photovoltaic panels installed on the roof of a building which is connected to main power supply unit.

Who is eligible for Pradhan Mantri solar Yojana?

As mentioned before, the citizens (with yearly income up to Rs. 1 to 1.5 lakhs) who are under the poverty line (BPL) or belong to the middle-class are eligible for the Pradhan Mantri Solar Yojana.
