CEC offers low interest loans to help customers finance solar water heaters and solar pool heaters. Basic qualifications for an energy conservation loan include a good credit history, good payment record with Clay Electric and service with CEC for one year. An energy survey conducted by a CEC representative within the past year is required.





The state's Connecticut Property Assessed Clean Energy (C-PACE) program accelerated the success in solar. Connecticut offers substantial solar power rebates, for installations of up to 10-kilowatt. For a 10-kW system, the state will offer you \$460 back per kW, which effectively means that you can get \$4,600 from the program at its maximum limit.



In November 2008, voters in Missouri approved by a ballot initiative (i.e., via an initiated state statute) the Missouri Clean Energy Act, also known as Proposition C, which repealed the state's existing voluntary renewable energy and energy efficiency objective and replaced it with a mandatory renewable portfolio standard (RPS). Though small, Maryland has emerged as a leader in solar policy. In 2007, it passed the EmPOWERing Maryland Act, which required a reduction in the state's overall energy use through efficiency and alternative power. State officials expect to meet the Act's 15% goal by the end of this year. In 2012, the state enacted a goal of 2% solar capacity by 2020.

To support the cost of loans for clean energy technologies. IRA provided \$40 billion of additional loan guarantee authority supported by \$3.6 billion in credit subsidy for projects eligible for loan guarantees under section 1703 of the Energy Policy Act of 2005. This authority is open to all eligible Title 17 Clean Energy technology categories



Under the authority of this law, California's first community choice aggregator, Marin Clean Energy (MCE), was launched in May of 2010. The Marin Energy Authority comprises each city and town in Marin as well as the communities of Belvedere, Fairfax, Mill Valley, San Anselmo, San Rafael, Sausalito, Tiburon, and the County of Marin.

Interstate Power and Light (Alliant Energy), in conjunction with Wells Fargo Bank, offers a low-interest loan for residential, commercial and agricultural customers who purchase and install energy efficient measures. If a loan term of 12 months or less is chosen, the customer is eligible for a loan with no interest; longer terms are eligible for the 6.9% interest rate.



The Colorado Clean Energy Fund provides loans for home energy upgrades through the Residential Energy Upgrade (RENU) Loan Program.

Participants must work with a RENU-approved contractor to identify energy improvements and receive a cost estimate. Customers must then apply for the loan through Elevations Credit Union.
