




"On August 16, 1939 the City of Columbia, Tennessee acquired through purchase, the properties of The Tennessee Electric Power Company in Columbia and a large area adjacent thereto in Maury County and one community in Williamson County and to accomplish this purchase sold electric revenue bonds in the amount of \$800,000 dated June 1, 1939

Junction boxes, troughs, or main breakers are not accepted on the source side of multi-metered developments. To provide CPWS needed access a 40-foot easement on primary and a minimum of 10-foot easement for overhead service conductors will be required.
