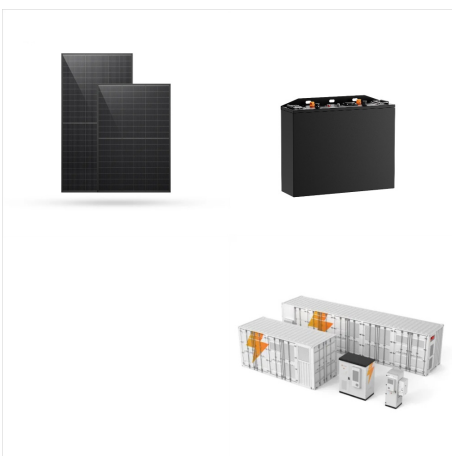

The typical cost per watt of solar in Calhoun County, TX in September, 2024 is estimated at \$3.26/W. Applying the price, we can come to the conclusion that for every 1 kW (1000 watts) of solar power capacity will cost you \$3,260 for installation.



Solar power usage in Calhoun County has gone up by 106.19% year over year, with 501,527 megawatt hours being generated from solar within the past 12 months. Citizens in Calhoun County face an average of 0.96 outages lasting 176.38 minutes per year, compared to the US averages of 1.44 outages at 123.49 minutes per outage.

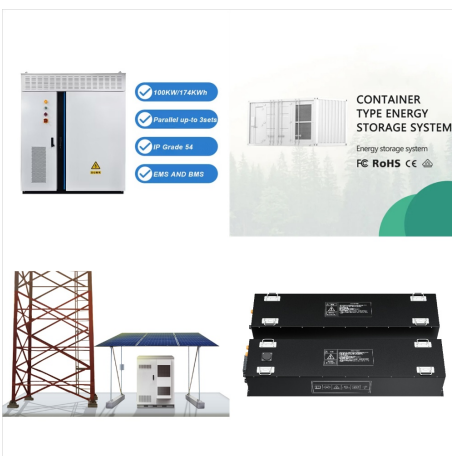

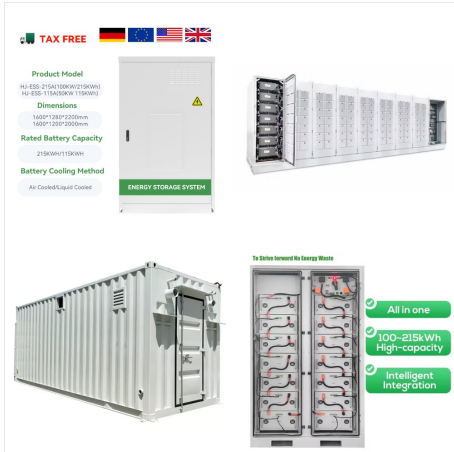

Port Lavaca, close to 130 miles southwest of Houston, is the county seat of Calhoun County. Calhoun County Commissioner David Hall calls the project "a game-changer for innovation in the sustainable energy space."



Calhoun County is 185th out of 3230 counties in the US in solar power generation, with 203,686 megawatt hours generated from solar. On average, Calhoun County citizens are accountable for 4,341.84 kilograms of CO2 emissions per person, while the statewide average pollution per capita is 5,553.9.

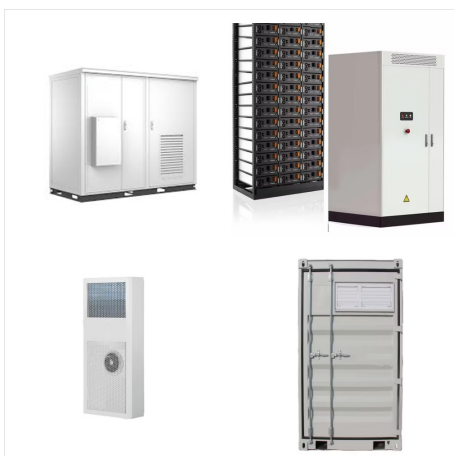

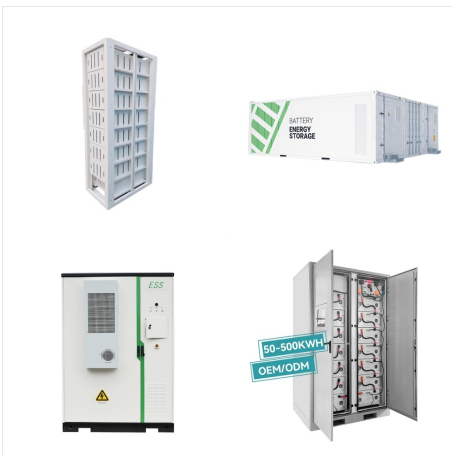
