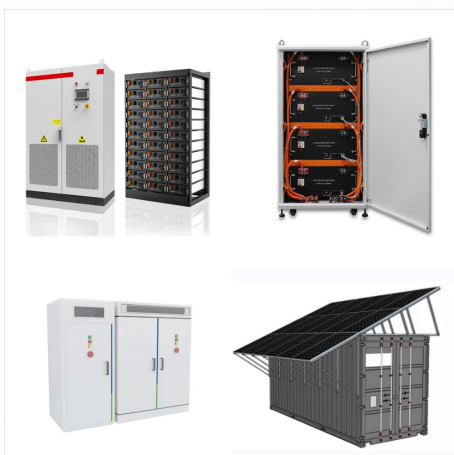

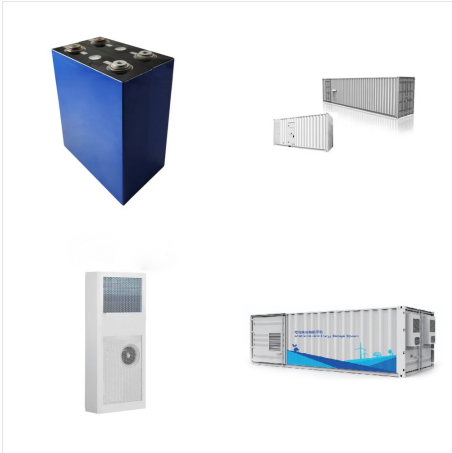

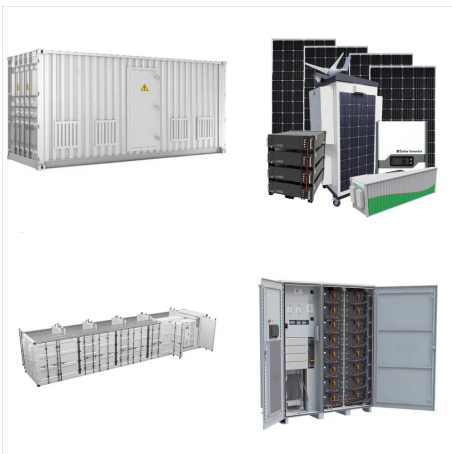

Dermen also reportedly laundered \$3.5 million through his California company, SBK Holdings USA Inc., to purchase a mansion in Huntington Beach, California.

Jacob Kingston, Isaiah Kingston, and Lev Aslan Dermen (aka Levon Termendzhyan), owner of California-based fuel company NOIL Energy Group, allegedly schemed to file false claims for renewable fuel tax credits, which caused the IRS to issue over \$511 million to WRE. Jacob Kingston is separately charged with filing nine false claims for refund on



Dermen and Jacob Kingston also laundered \$3 million through Dermen's company, NOIL Energy Group, to purchase a mansion in Sandy, Utah for Jacob and Sally Kingston. The Kingston defendants sent over \$35 million of their share of the fraud proceeds to their extended family and companies they owned.
