The Connecticut Department of Energy and Environmental Protection (DEEP) is in the process of developing federal applications for HER and HEAR in order to access the funding. Please note that HER and HEAR rebates will not be available until our federal applications are approved by the US Department of Energy (DOE).



Grid Edge customers are eligible for increased incentives under the Energy Storage Solutions Program. 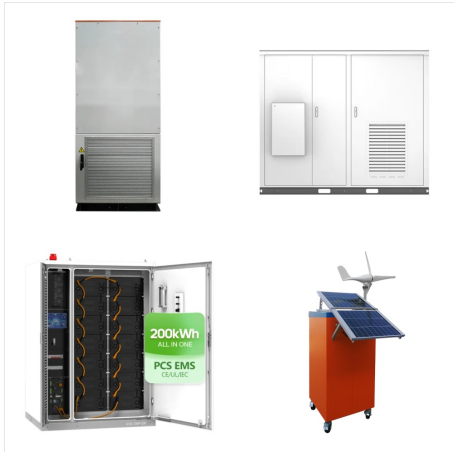

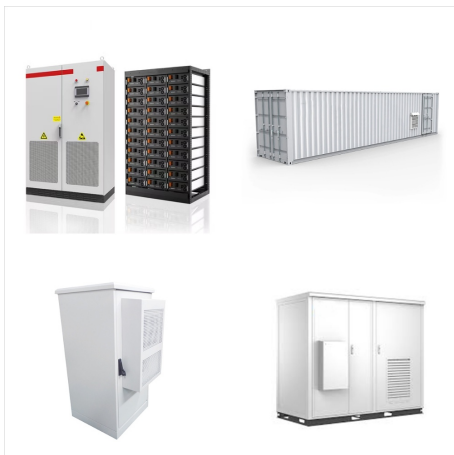
