What is Croatia's energy strategy?

The Strategy includes a wide range of energy policy initiatives that will improve energy security, increase energy efficiency, lower dependence on fossil fuels, increase local production and increase renewable resources.

Does Croatia have a nuclear reactor?

Croatia also co-owns the Krsko nuclear reactor in Slovenia, which is included in its energy mix as imported electricity. In order to become energy-independent and sustainable, Croatia counts on its abundant renewable energy resources.

Could Croatia have been a regional oil and gas import hub?

Croatia could have already assumed a much bigger role as a regional oil and gas import hubhad it not delayed and scaled back the construction of its LNG terminal for a decade, said András Simonyi, an energy expert at the Atlantic Council's Global Energy Center. "The Croats are very late," Simonyi said.

How can Croatia improve energy security?

In order to strengthen energy security and reduce energy imports from third countries, Croatia is exploring the possibility to increase the production of domestic hydrocarbon resources. At the same time, Croatia also has plans to diversify natural gas supply routes by constructing an LNG terminal on the island of Krk.

How much energy does Croatia import?

Croatia imports about 54.54% of the total energy consumed annually: 74.48% of natural gas,78.34% of oil and petroleum products, and 100% of its solid fossil fuel needs. Croatia also co-owns the Krsko nuclear reactor in Slovenia, which is included in its energy mix as imported electricity.


