
When will HBA deliver FPSO in West Africa?

On December 21st 2021,HBA has entered into a consortium agreement to deliver and operate an FPSO for a private Oil &Gas Company in West Africa. Engineering and construction have begun in Q1 2022 and delivery is expected in Q2 2023with the operations contract signed until 2028.


