DANGLING ROPE MARINA HYBRID POWER SYSTEM



The National Park Service has been discussing Dangling Rope Marina since 2021 when a microburst storm damaged its electrical system. Before the storms, the NPS had plans to upgrade the electrical system when a sewage lift station separated from the dock and sank, which caused delays in 2017. Shortly after, the world stopped due to the COVID-19 pandemic, ???



The Dangling Rope Marina served as a floating structure with visitor services, including a mid-lake fuel service station. It was the only chance to refuel in the 100-mile area between downlake



Lake Powell boaters are advised that Dangling Rope Marina is not open and there is not any power, fuel, water, pumpout or other visitor services at the marina until further notice. The marina closure is due to an ongoing project to repair and upgrade the electrical system. The park anticipates that power, fuel and limited visitor services

DANGLING ROPE MARINA HYBRID POWER SYSTEM



Originally built in the early 1980s as a fuel, food, supply and boat repair stop for visitors boating between Wahweap and the uplake marinas of Bullfrog and Halls Crossing, Dangling Rope Marina replaced Rainbow Bridge Marina, a floating dock system that was anchored to the side of a cliff with no land access.



KANE COUNTY, Utah ??? Because of unprecedented low water conditions, the Dangling Rope Marina will remain closed all year. The decision to shutter the facility in 2022 is in response to lowering lake levels. Concessioner and park staff crew are in the process of removing marina components to ensure boats don't become beached and inaccessible.

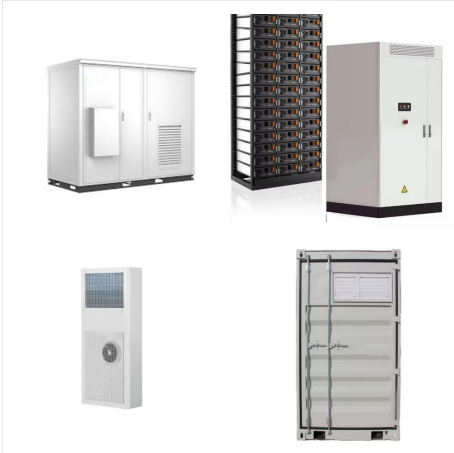

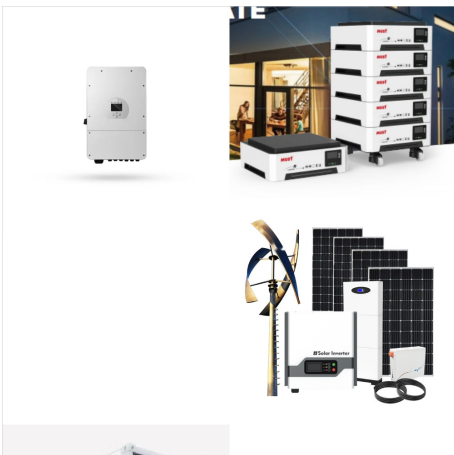
