#### Do I need planning permission for a solar PV project?

The rules apply to both solar thermal panels and solar PV. However, permitted development rights do not always apply as there are a few exemptions. If your project falls into one of these, you will require planning permissionunless you can make any adjustments to your plans. Exceptions can include:

Can solar panels be installed without a planning system?

Changes to permitted development rights rules will mean more homeowners and businesses will be able to install solar panels on their roofs without going through the planning system. Currently those who have to go through the planning system are having to wait over eight weeks and face extra costs.

Do I need planning permission to install solar panels?

Rules can vary between local authorities too, so if you're thinking of installing panels then it would be wise to first check the Planning Portal website, which covers England and Wales, or MyGov.scot for Scotland. If you think you'll need planning permission and want to apply, you can skip to the bottom of this article for links and details.

Can I install solar panels on a listed building?

Listed Buildings Whilst it may be possible install solar panels on a building that is located within the grounds of a listed building or on a site that is considered to be a scheduled monument. It requires listed building consent followed by applying for planning permission.

Do I need planning permission to install solar panels in Scotland?

An MCS contractor will also confirm that your solar setup meets all the aforementioned requirements before the installation commences. There are further rules that apply for installing solar panels in Scotland; planning permission is required if they are to be installed onto the wall of a block of flats or on a flat roof.

Do I need planning permission to install a solar array?

To be safe we recommend you check all installations with the local planning office. Ground mounted installs will generally need planning permissionunless the array is less than 9 square meters, but even then you should check.
