Does the government offer free solar panels?

While the government isn't offering free solar panels, it offers a tax credit that can be claimed on federal income taxes for those who use solar power on residential property. The credit was increased and extended through 2034 by the Inflation Reduction Act.

Do solar panels qualify for a tax credit?

The installation of the system must be complete during the tax year. Solar PV systems installed in 2020 and 2021 are eligible for a 26%tax credit. In August 2022,Congress passed an extension of the ITC,raising it to 30% for the installation of which was between 2022-2032.

Who qualifies for the federal solar tax credit?

To qualify for the federal solar tax credit, the taxpayer must own the solar energy system. Those in a lease or a power purchase agreement (PPA) with the solar installer aren't eligible for the tax credit, as they aren't considered system owners. Additionally, the taxpayer's tax liability has to cover the amount of the credit.

Are there free solar panels in Florida?
