

Does ups ship lithium ion batteries?

This label indicates what the contents of the shipment are, and UPS won't accept the package into their network without it. Of course, UPS also allows for air transportation of lithium-ion batteries if they're packed within the equipment they power (just like USPS does).

Can I ship a lithium battery by Air Service?

Shipping lithium batteries by air service Regulations differ depending upon what type of lithium battery you are shipping (lithium ion or lithium metal) and whether you are shipping batteries packed with equipment or batteries contained in equipment. Reminder: UPS does not accept Section II shipment

Can I ship a lithium battery without equipment?

Lithium Batteries packed without equipment: UPS only accepts air shipments of UN3090 or UN3480, lithium metal or ion batteries packed alone (without equipment) as fully regulated shipments. Section II or 49CFR 173.185 (c) will not be accepted for air transport. Follow this link for more information about lithium battery shipping.

Does USPS ship lithium-ion batteries?

USPS isn't the only game in town when it comes to shipping lithium-ion batteries; you can use other carriers like UPS, too! The thing is, UPS also considers lithium-ion batteries as a type of hazardous material, so you'll need to follow a certain process when it comes to shipping them. We've laid out what you need to do below.

Can I send lithium-ion batteries outside of my equipment?

You can download a UPS Dangerous Goods Contract here. That's the only way you'll be able to send lithium-ion batteries packed outside of any equipment with any of the UPS air services. Some shipping software platforms have different rules when it comes to allowing lithium-ion battery shipments with UPS.

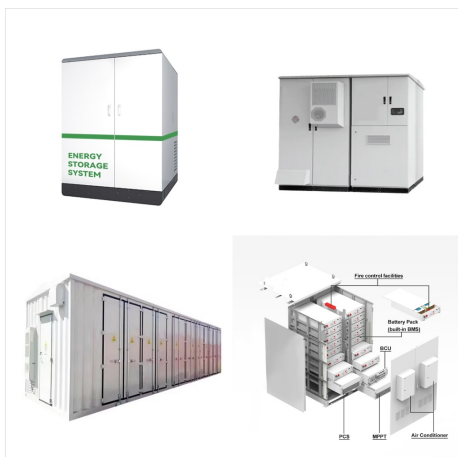
Does ups provide service for battery shipments?

UPS Provides service for Battery Collection, Recycling, and/or End of Life Battery shipments when tendered in UPS-approved U.S. DOT Special Permit packaging designed to contain a thermal event. The program requires pre-approval and a specialized service agreement, please contact your account representative for more detail on this program.

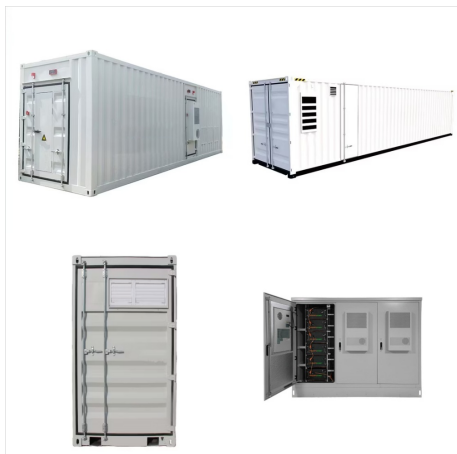


For shipping lithium batteries with USPS overseas, you can ship a maximum of 4 cells or 2 batteries that are installed in the new or certified refurbished equipment or device it operates, without any lithium battery markings. However, individual batteries are prohibited from USPS international shipping.

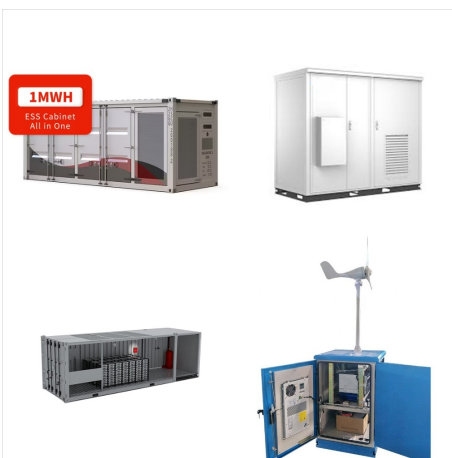

Shipments of lithium metal batteries, lithium metal batteries packed with equipment, and lithium metal batteries contained in equipment may be packaged in accordance with Section II IATA (Section II ICAO) packaging requirements provided that the metal or alloy cell content does not exceed more than 1g, and the aggregate lithium content does not

UPS will continue to accept lithium batteries contained in or packed with equipment by air prepared in accordance with the Section II (P.I.s 966, 967, 969 and 970) requirements; however, it is important to note that UPS has additional marking requirements for these shipments that became effective on 1/1/17, as outlined in the UPS Operator Variations (5X) contained in ???

If you're shipping lithium ion batteries as a standalone (UN 3480) via air, there are new regulations you need to be aware of. Shipping Lithium Ion Batteries with UPS. UPS restricts damaged, defective, or recalled lithium batteries to ground transportation. Customers wishing to ship these faulty batteries must be pre-approved by UPS.



This document describes the rules for shipping small lithium batteries packed with or contained in equipment for which UPS does not require a UPS Dangerous Goods contract. 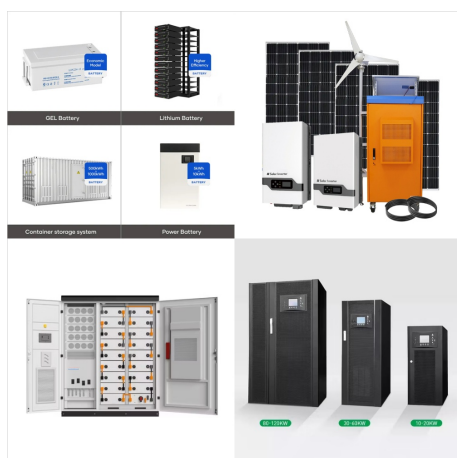
