Does Duke Energy have a solar rebate program in North Carolina?

What is the Duke Energy Rebate program?

The program is part of 2017's Competitive Energy Solutions for North Carolina law - also known as House Bill 589 - which includes new Duke Energy programs to benefit customers. How much is a solar energy rebate?

Under the program, residential customers will be eligible for a rebate of 60 cents per wattfor solar energy systems 10 kilowatts (kW) or less. For example, a typical rooftop array of 8 kW would be eligible for a \$4,800 rebate. Installed systems 10 kW or greater would be eligible for a maximum rebate of \$6,000.

Does Duke have a solar incentive program?

Duke has proposed a new, limited solar incentive programas part of a controversial overhaul of rooftop solar regulations. But it comes with lots of strings attached and it's not clear if regulators will approve it. Meanwhile, there's still a federal tax break for home solar, though that ends next year.
