



Does SCE endorse or recommend a solar contractor?

SCE does not endorse or recommend any solar contractor. SCE partners with GRID Alternatives to promote the Disadvantaged Communities - Single-family Solar Homes (DAC-SASH) program (as described below).

What is the solar billing plan?

The Solar Billing Plan succeeds the Net Energy Metering (NEM) 2.0 program. If you are an SCE customer and interested in increasing the reliability of your electric service, be better prepared for outages and Public Safety Power Shutoffs (PSPS), we offer incentives available through the Self-Generation Incentive Program (SGIP).

How do I find a solar contractor in California?

A qualified, licensed solar contractor will provide you with a free home evaluation and comprehensive quote. Obtain and compare multiple bids before beginning. How: If you can, get referrals from friends and neighbors. Search for active solar contractors in your area by using the California DG Stats Search tool.

What incentives are available to reduce solar installation costs?

There are multiple incentive programs available to reduce the upfront costs associated with solar system installations. They are the: Disadvantaged communities (DAC) or disadvantaged communities Single-family Affordable Solar Homes (DAC_SASH) programs. These programs provide free or discounted home solar systems to those who qualify.

How much does solar cost in Miami FL?

The average price per watt of solar power in Miami, FL is \$2.42/W. These prices are before incentives. After the federal solar tax credit, the final cost will drop by 30%, down to \$25,868 for a 15.26 kW system. Many states even offer local rebates and incentives that lower the price further--sometimes by thousands of dollars.

On April 15, 2023, NEM 2.0 closed to new customers and a new Solar Billing Plan went into effect. NEM accounts will continue to bill under the current NEM program until the 20-year period expires, or until the account loses eligibility to remain on the NEM program, whichever is earlier. On July 11, 2019, the CPUC approved Resolution E-5000

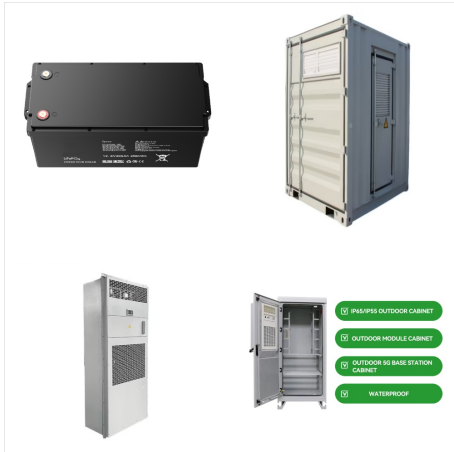

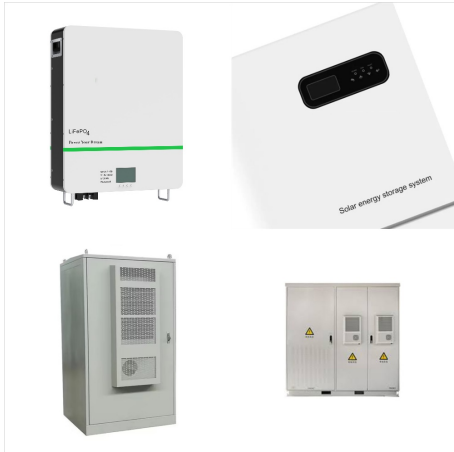

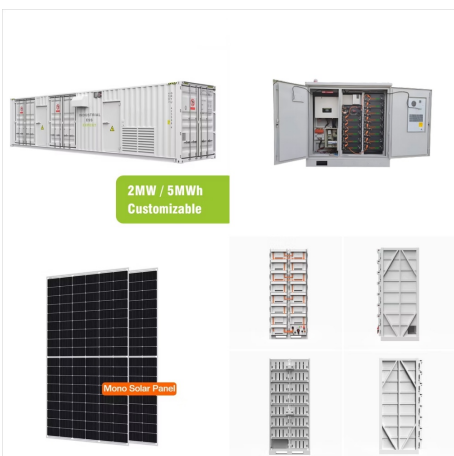
