



The project is currently owned by Elliott Green Power. Nevertire Solar PV Park is a ground-mounted solar project which is spread over an area of 445 acres. The project generates 265,000MWh electricity and supplies enough clean energy to power 44,000 households, offsetting 221,000t of carbon dioxide emissions (CO2) a year.

As part of the transaction, Igneo will also integrate Elliott Green Power Australia's management team into Atmos Renewables. Elliot put its solar power generation portfolio up for sale last year.
