

The Oman Arbitration Act is based on the UNCITRAL Model Law. The Oman Arbitration Act is supplemented by the Civil Procedure Law (Royal Decree No. 29 of 2002) and Oman's adoption of the New York Convention (Royal Decree No. 36 of 1998). In general, sovereign immunity is not a recognised doctrine in Oman.
