

What is Bermuda's Integrated Resource Plan?

On July 26, 2019, the RA released Bermuda's first Integrated Resource Plan, which outlined the framework for Bermuda's energy requirements over the next 25 years. The IRP aimed to have 85% of Bermuda's power generated by renewable means by 2035.

Who is Bermuda Electric Light Company?

In the 1950s, we decided against developing a tramway for the island and so removed the word "Traction" from the Company's name and became what we all know today as the Bermuda Electric Light Company Limited - BELCO. We embraced new technologies as we grew.

How much electricity does Bermuda use?

Large commercial organizations use about 40% of electricity produced. The standard voltage in Bermuda is 120 V and the standard frequency is 60 Hz AC. Flat, two-pronged plugs (Type A) are in use. All US and Canadian appliances work on the island, without voltage converters or adapters.

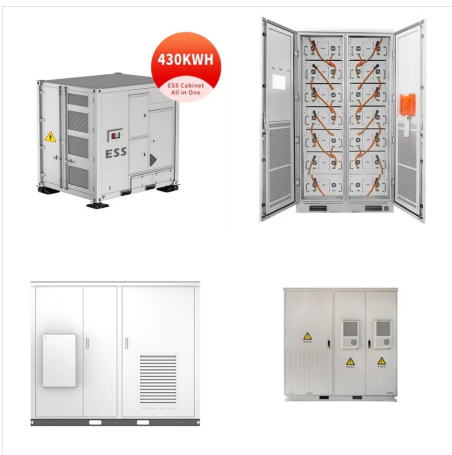
