An Act To Advance Energy Storage in Maine, Public Law 2021, chapter 298 (Act)1. The Act established energy storage goals for the State of 300 MW and 400 MW by December 31, 2025 and December 31, 2030, respectively. The Act also directed certain Public Utilities Commission; consideration of power-to-fuel pilot program.



The procurement also includes up to 1 GW of geothermal energy that can be commissioned between 2031 and 2037 and 7.6 GW of floating offshore wind that can be commissioned between 2035 and 2037.
