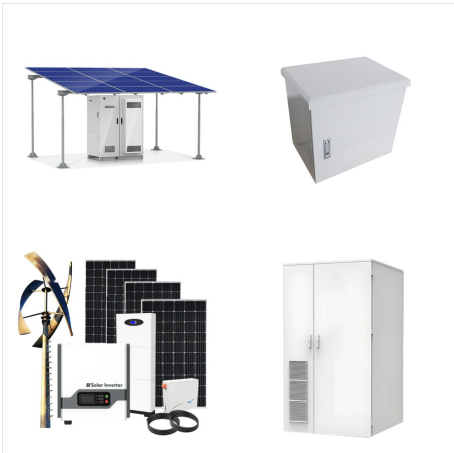
Which businesses lend themselves to sole proprietorships?
