

Does FedEx ship lithium batteries?

• Lithium Metal Batteries: Contained (UN 3091 - Packing Instruction 970) Set up a FedEx shipping rule for your shipments that contain lithium batteries as you would normally do, select the FedEx service and format of your preference and then add the correct lithium battery type as an enhancement from the Enhancements drop-down menu.

Does FedEx accept regulated battery shipments?

FedEx Office®; Print and Ship Center locations do not accept regulated battery shipments, with the exception of lithium battery shipments meeting Section II IATA regulations. How to Pack guidelines. Refer to the FedEx Logistics lithium battery shipping guide for specific guidelines regarding international air and ocean requirements.

How do I prepare and package my lithium battery shipments?

Do I need a lithium battery handling label?

If the package contains less than 4 non-button cells or 2 batteries, Lithium Batteries Handling Label is not required. 5. Marking: (if) Lithium batteries "packed with" MIX with "contained in" package, shipper must mark a statement on the outer surface of the box.

Do I need a specific lithium battery Shipping Class?

FedEx Ground strongly recommends that anyone shipping lithium batteries take a specific lithium battery shipping class in order to better understand these complex regulations and meet DOT/ICAO/IATA/IMDG/USPS requirements.

Can lithium batteries be shipped by air?

WARNING: Lithium batteries that have been recalled by the manufacturer for safety reasons **MUST NOT** be shipped by air. This package must be handled with care. A flammability hazard exists if the package is

Q: Does the January 1, 2022 IATA rule change impact lithium batteries shipped by air using FedEx Express? A: No, the change does not impact lithium battery shipments using FedEx Express shipments by air. Lithium batteries UN3490/UN3090 Section II shipments have been prohibited from shipping using FedEx Express air services since 2017.

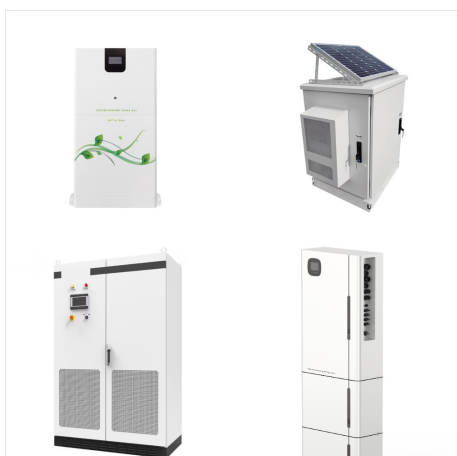

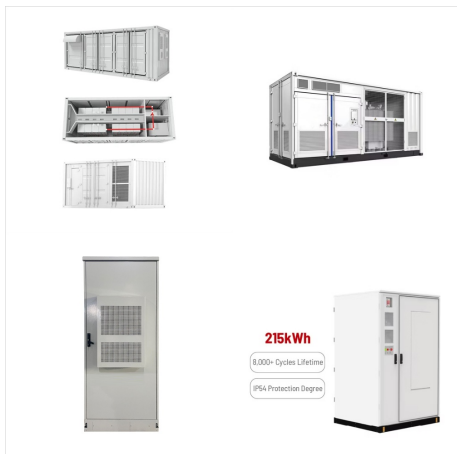

Exceptions: FedEx Express white and brown boxes and tubes may be used for FedEx Express UN 3091 and UN 3481 Section II lithium battery shipments. The FedEx Pak may also be used to ship UN 3091 and UN 3481 Section II lithium batteries in strong rigid packaging (e.g. fibreboard box) when the package does not require a lithium battery mark.

If a mistake is made on the Shipper's Declaration for Dangerous Goods form, the shipper may correct the form then handwrite their full signature next to the alteration or amendment. Most FedEx Ship Center (R) locations do not accept dangerous goods shipments, except for permitted IATA Section II lithium batteries. FedEx Express dangerous

Packages containing lithium batteries must be packaged in accordance with Packing Instruction (965-970), utilizing the suitable Section IA, IB, or Section II shipment type. FedEx Express prohibits UN3090 or UN3480 offered as Section II. They must be offered as Section IA or IB. In addition,

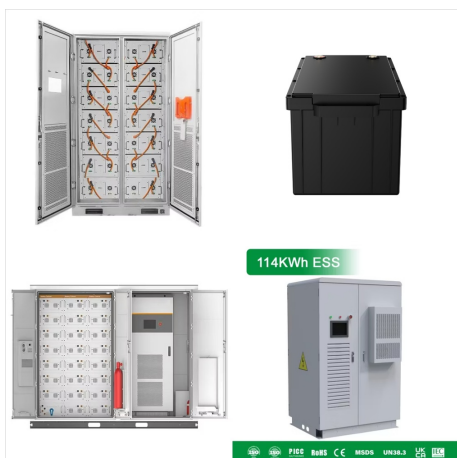

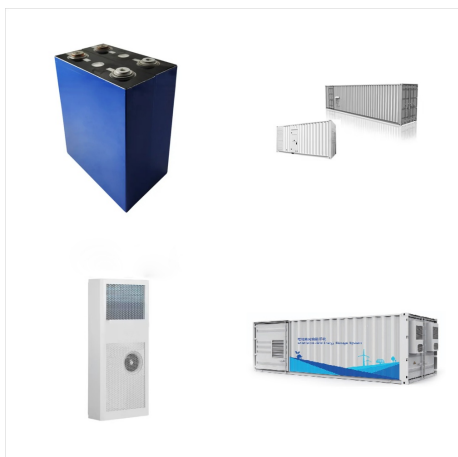

Some goods, such as explosives and poisons, are clearly dangerous. But other restricted items may surprise you. For example, flammable items such as paint or perfumes are hazardous material as these pose hazard in shipping. Products that contain lithium batteries ??? such as mobile phones or laptops ??? may also be subject to restricted delivery.

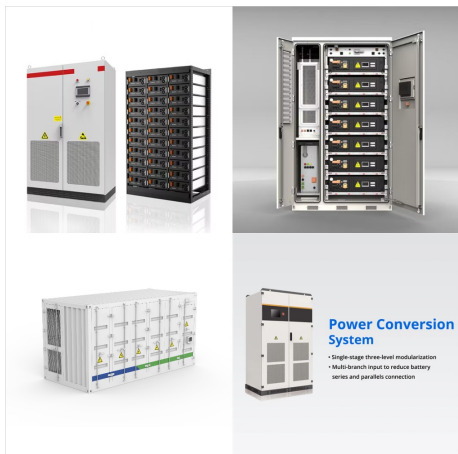

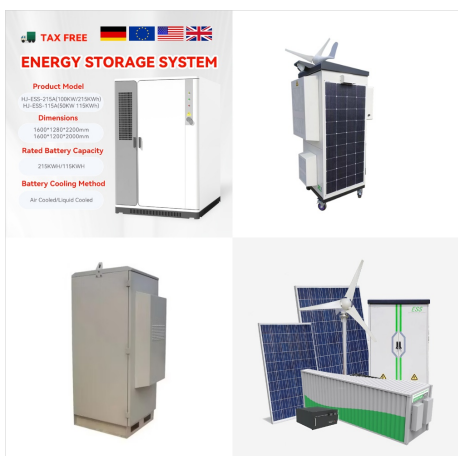

When the Lithium Battery Mark (IATA Figure 7.1.C) is required and used for Section IB and permitted Section II lithium battery shipments, the UN number(s) must be added to the mark. The UN number indicated on the mark should be at least 12 mm high. Note: The Lithium Battery Mark cannot be folded or wrapped around multiple sides of the package.

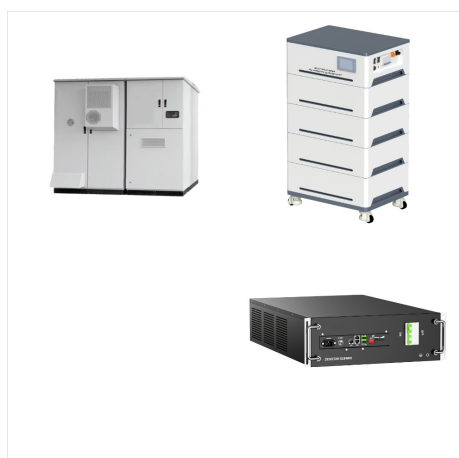

Exception: If the only lithium batteries are those contained in temperature control devices and the lithium batteries are Section II. The package must also not require the Lithium Battery Mark and ELB (FedEx Express DG handling code for Section II batteries) must not be selected in the automation device. [FX-05C]
