

Like for many other SIDs Fiji's geographical situation means that affordable and accessible energy supply is a challenge. The Island state depends heavily on imported fossil fuel to meet its energy needs,nevertheless,renewable energy sources,mainly hydro,account for 55% of the country's total energy production.

Does Fiji have electricity?

The rest of the islands in Fiji are electrified through diesel generator sets, micro hydro systems or generators running on biofuel. The electrification of the off-grid population comes under Fiji Department of Energy (FDoE). Selected PICs' demography and energy data. The access to electricity in Fijian households in not 100 %.

What is the energy situation in Fiji?

It is a small island developing state (SIDS) that is heavily dependent on imported fossil fuelfor its energy needs. The paper attempts to determine the past and current energy situation in Fiji, challenges faced and strategizes to overcome these challenges. In 2014, Fiji generated 859 GWh of grid electricity from 259.8 MW of power plants.

Will Fiji be able to produce 100% of electricity by 2030?

10.3.1 To derive as close to 100% of electricity services from renewable energy sources as possible by 2030. In keeping with Fiji's climate change commitments and development goals, Fiji will systematically scale up the transition to renewable energy-based electricity production.

Does Fiji have a national energy policy?

Using external aid (German Technical Cooperation (GIZ) - Deutsche Gesellschaft fur Internationale Zusammenarbeit and United Nations Development Programme (UNDP)), Fiji has been able to successfully review National Energy Policy for Fijiwhich acts as a guideline for the goals and objects to achieve by 2030.

Where does Fiji's Electricity come from?

In 2014, 55% of Fiji's electricity was generated using renewable energy resources, making it the island state in the entire Pacific with the lowest oil dependency. In fact, on several of Fiji's larger islands 60% of electricity comes from hydropower and biomass.
