

As the European Union finalizes its third Renewable Energy Directive (REDIII), France is seeking an exemption to enable the European Space Agency and French Space Agency to build and operate two biomass power plants in French Guiana.

What is ESA & CNES doing for French Guiana?

ESA, CNES and industrial operators are creating a new chapter in the history of Europe's Spaceport.

Together they are using renewable energyas a key component in launchers competitiveness while serving the local community and ultimately French Guiana as a whole.

Is French Guiana a'soft power'?

The Amazon rainforest covers more than 90% of the territory. However, French Guiana is critical to Europe's soft power. It is home to the continent's spaceport where the European Space Agency launches its satellites. Now, the French government is seeking exemptions from proposed EU rules that would restrict the use of bioenergy on the territory.

France is seeking a waiverto EU bioenergy rules that would allow the forest-covered territory of French Guiana to receive subsidies to produce biofuels for the space industry. Wedged between Brazil and Suriname, the overseas department has little in common with mainland France bar the name.

Are EU rules threatening French Guiana's ambition to move away from fossil fuels?

Authorities in French Guiana argue the EU's proposed rules threatened the territory's goal to move away from fossil fuels, including at the spaceport, which consumes 18% of the electricity produced locally. Two biomass



plants, totalling 9MW, are being built to produce electricity and cooling for operations at the space station.






Once up and running, it will increase the capacity of the Toco energy storage complex to 19.3 MW/25.6 MWh. Voltalia noted that Sable Blanc benefits from a 20-year guaranteed tariff. 
