

If you own a renewable energy resource you have the ability to convert power into a tradable Renewable Energy Certificate (REC). A REC is created for every megawatt-hour, or every 1,000 kilowatt-hours, of electricity generated and is the commodity traded in compliance markets in states that have Renewable Portfolio Standards programs.
