Geronimo Energy, a National Grid (NYSE: NGG) company, is a leading North American renewable energy development company based in Minneapolis, Minnesota, with satellite offices located throughout multiple states in the regions where it develops, constructs, and operates.

What is National Grid's acquisition of Geronimo Energy?

On 15 July 2019, National Grid, through its competitive non-regulated unit National Grid Ventures (NGV), completed its \$100 million acquisition of Geronimo Energy - a leading wind and solar developer in North America. The deal, which was announced on 7 March 2019, has now satisfied all regulatory requirements and closing conditions.

Where is Geronimo Energy now?

Geronimo Energy will continue to be headquartered in Minneapolis, with satellite development offices and operational project facilities located throughout the country. "We're very pleased to have officially joined the National Grid family today," said Blake Nixon, chief executive officer for Geronimo Energy.

What happened to Geronimo Energy?

The acquisition process is expected to conclude in the second quarter of 2019, when Geronimo Energy will officially become a National Grid plc company. Does Geronimo have a solar deal?

The deal was first announced this spring. Minneapolis-based Geronimo claims to have developed more than 2.2 gigawatts of renewables capacity since being founded in 2004, with its historical focus on wind in the Upper Midwest having blossomed into a more geographically diversified portfolio that increasingly includes utility-scale solar.

Who is the CEO of Geronimo?

Blake Nixon, CEO of Geronimo, will continue to lead the business, reporting to Daniel Westerman, President Distributed Energy and Renewables, NGV. This new acquisition continues our investment in clean energy.



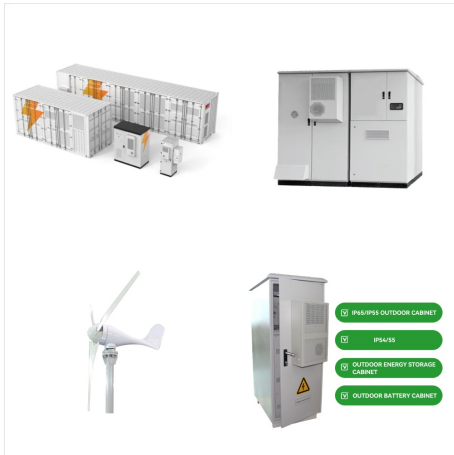
