How does the European Commission support agrivoltaic projects in Italy?

The European Commission has approved a EUR1.7 billion (US\$1.8 billion) scheme to support the deployment of 1.04GW of agrivoltaics projects in Italy. Set to run until the 31 st December,2024,the funding comes in part through the Recovery and Resilience Facility,which was introduced by the EU to aid in economic recovery from the COVID-19 pandemic.

Does Italy need a solar PV system?

While Italy has made significant strides in solar PV installations, additional measures are needed to enhance financing, training programs, and public awareness. Additionally, improvements in grid infrastructure are crucial to support the transmission of renewable electricity across regions.

How will Italy contribute to the green energy transition?


This EUR5.7 billion scheme enables Italy to support the production and self-consumption of renewable electricity by energy communities. It will strengthen citizens' engagement and first-hand participation in the green energy transition by supporting local communities to multiply renewable power generation installations.

The European Commission announced last week it had approved a EUR5.7 billion scheme for the deployment of energy communities Italy. 




