

How do I mail a lithium battery?

1. The primary lithium cells and batteries must be mailed in "the originally sealed packaging". 2. The sealed packages of batteries must be separated and cushioned to prevent short circuit, movement, or damage. 3.

How do I ship a lithium battery?

USPS has official instructions and guidelines for shipping batteries. ShipSaving helps you to highlight the following information: All packages containing lithium metal or lithium-ion batteries that can be mailed must be of sufficient size, sealed, and rigid. This ensures that the lithium battery mark can be affixed to the address without folding.

Can a lithium battery be attached to a mailpiece?

Except for mailpieces containing button cell batteries properly installed in the equipment they are intended to operate, mailpieces containing mailable lithium metal or lithium-ion batteries must be rigid, sealed, and of adequate size, so the lithium battery mark can be affixed to the address side without the mark being folded.

Can I ship lithium batteries via USPS?

#1: Yes, you can ship lithium batteries via USPS. However ... There are currently six types of lithium batteries eligible for shipment, in varying domestic or international quantities, via USPS: Don't forget the new lithium battery marks that became mandatory this year!

Can a battery be shipped via USPS?

USPS battery shipping allows you to ship it under certain conditions, but there are still some types of batteries that cannot be shipped. The following introduces nonmailable and mailable situations: USPS has strict rules for shipping batteries, and one of the most critical factors is Watt hours (Wh).

Can I ship lithium batteries overseas?

For shipping lithium batteries with USPS overseas, you can ship a maximum of 4 cells or 2 batteries that are installed in the new or certified refurbished equipment or device it operates, without any lithium battery markings. However, individual batteries are prohibited from USPS international shipping.

DMM Revision: Mailings of Lithium Batteries .

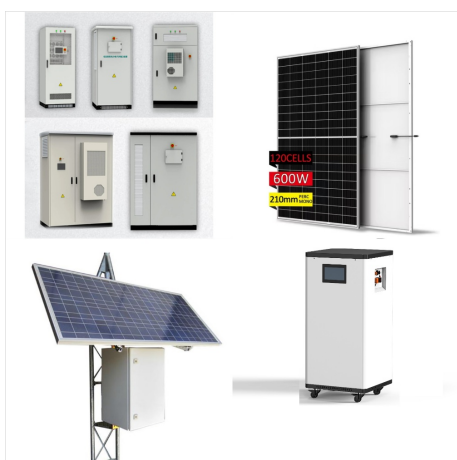

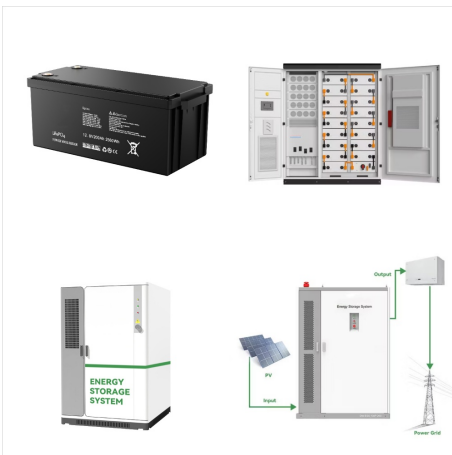


Nonspillable batteries with UN2800 are prohibited in international mail but may be sent as domestic mail via air or surface transportation when prepared within the conditions of Packaging Instruction 8B in Appendix C. For lithium and lithium-ion batteries, see 349.22. Hydrochloric Acid (UN1789). Acceptable only in solutions not exceeding 10

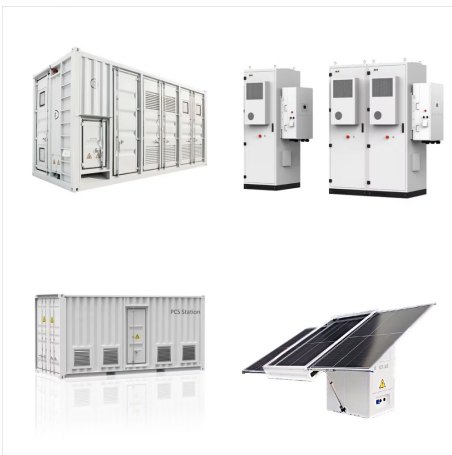


HAZMAT items include but are not limited to explosives, flammable and combustible materials, and radioactive materials. 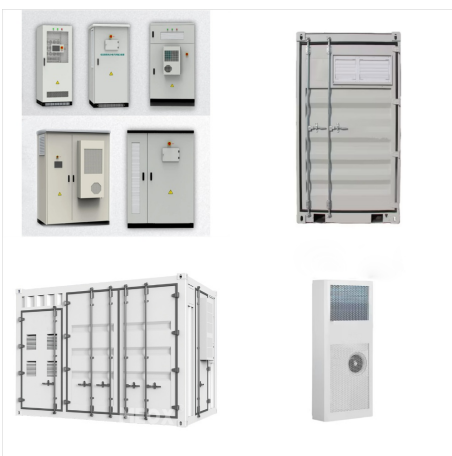
HOW TO MAIL LITHIUM BATTERIES USPS



Each lithium metal cell and battery must contain no more than 0.3 gram of lithium content. Each lithium-ion cell/battery must have a watt-hour rating of not more than 2.7 Wh. Mailpieces must not bear markings or labels identifying the contents as lithium batteries. Exhibit 622.5 . International Lithium Battery Mailability



Persons wishing to ship lithium batteries and electronic devices containing lithium batteries by mail should be aware that certain requirements must be met to ensure safety during transport. HOW TO MAIL LITHIUM BATTERIES USPS



Lithium batteries, which are used in most small electronic devices such as digital cameras, digital camcorders and cell phones, are considered hazardous materials because they have the potential of producing a dangerous evolution of heat, fire or short circuit. If shipping through the USPS, add an additional label stating "Surface Mail

The regulations for shipping batteries via USPS include the following: batteries must be properly packaged, marked, and labeled; certain batteries are prohibited from mailing; lithium batteries must not exceed certain watt-hour ratings; and additional documentation may be required for international shipments.

HOW TO MAIL LITHIUM BATTERIES USPS



When using an air transportation service like Priority Mail, you'll need the UN3481 Lithium Battery Handling Label. Sometimes, you may need to ship with a ground-based service, like when the lithium ion batteries are separate from the equipment they power. In this case, you'll need to affix this UN3480 label.



YES, you can ship Lithium Ion and Lithium Metal via air mail, any mail class. The only thing you cannot ship via air is Lithium Metal batteries without any other equipment. Lithium Metal are nonrechargeable, usually watch batteries or film camera batteries. Most lithium batteries are rechargeable lithium ion.

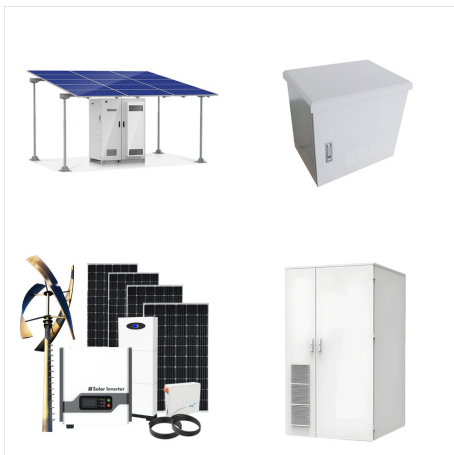

HOW TO MAIL LITHIUM BATTERIES USPS



If you are looking to ship a cordless drill through USPS, it is important to make sure you are following their regulations. First, the battery must be removed from the drill and shipped separately. Lithium-ion batteries must also be properly packaged and labeled with the battery type, weight, and "Contains Lithium Ion Batteries" warning.



When shipping with USPS, these items can only be sent via Ground Advantage. USPS is enforcing restrictions for used electronic devices containing lithium-ion batteries. You can't drop these items in a mail collection box; you need to take ???



According to the US Department of Transportation, there have been over 300 documented incidents involving lithium batteries carried as cargo or baggage since 1991, resulting in fires, explosions, and injuries (Source: US DOT). In one alarming example, a lithium battery caught fire in a UPS cargo plane in 2010, causing the aircraft to crash and killing both pilots ???

The Postal Service allows limited quantities of lithium batteries to be mailed domestically (within the U.S.) as long as certain conditions are met.
