How does ignite work?

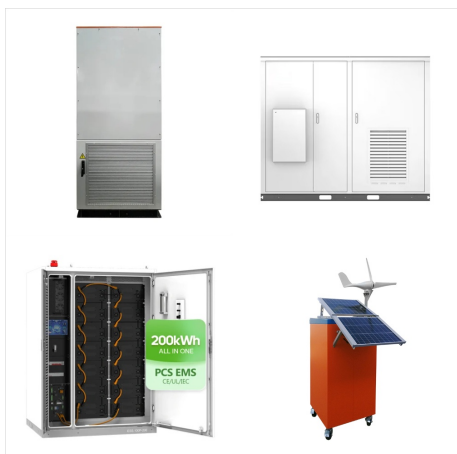

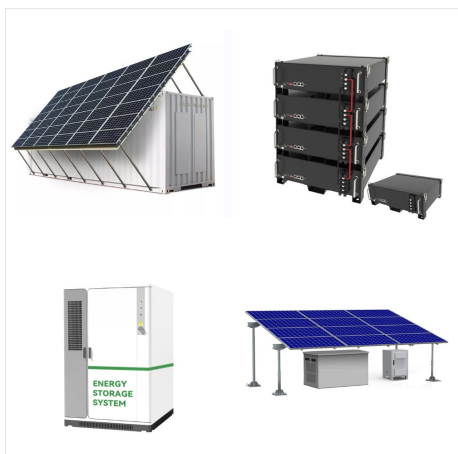

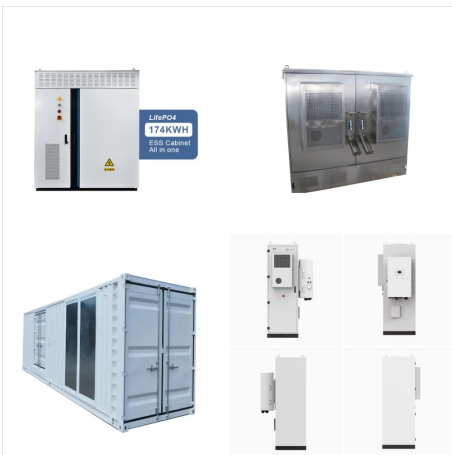
